Dear Mr. Weisberg:

I have ~~been~~ been in contact with you once before, in May 1976. At that time I made some inquiries concerning your books. I have delved very deeply into your book, POST-MORTEM. Needless to say, it is a very definitive and scholarly work. As I mentioned previously, I am doing a research thesis on the Role of Governmental Agencies in JFK's Assassination. Relevant ~~to~~ to this I should like to make two requests of you:

- 1) If at all possible, please put aside the following books for me:
  - a) WHITEWASH: The Report on the Warren Report
  - b) WHITEWASH II: The Secret Service-FBI Coverup.
  - c) PHOTOGRAPHIC WHITEWASH: Suppressed Kennedy Assassination Pictures
  - d) WHITEWASH IV: Top Secret JFK Assassination Transcript
  - e) a book you referred to as Oswald in New Orleans, you mention that you would make this book available to researchers for \$21.00.

---As soon as I am able to afford, I will send the money for these books. I realize that this is an unusual request--but I very much want to read these books, but being a student, money is often elusive.

- 2) I would like to have your written permission to use lengthy quotes, and diagrams and pictures, ~~from~~ your book POST-MORTEM, in my final paper. I plan on getting this paper copyrighted, and hope to get portions of it published. However, with no resources, it is not a paper dealing with new research that I found. Rather, it is a conglomeration of alot of the material that is in print now, drawing parallels and generally adding much strength to the fact that the government suppressed and covered-up damaging evidence. *Of course, all your material is and will be fully footnoted and documented.*  
--if you are interested, I would be honored if you would like to have a copy of the paper--hopefully to be completed this December or January.

Thanks so much for your time--hope the phlebitis you mentioned in your last letter has subsided.

P.S. Last month we had a speaker at Wesleyan named, "Peter James". He claims to have been with Pratt-Whitney Aircraft, and now is exposing the cover-ups he saw between the Air Force contractors, and the CIA. He wants to start a national center to accumulate and computer record all research materials relating to government suppressions and cover-ups. He was interested in the work I am doing and stressed the need for an "organization of related material concerning JFK's assassination." Do you know anything of this man? He also wrote two books, including the Air Force Mafia.
