MY HEART ATTACK HIT ME.

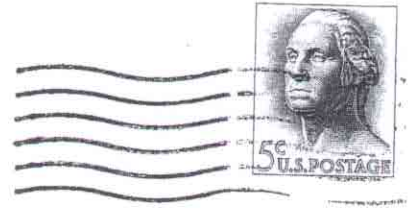
TWO MORE DAYS I GUESS THIS
