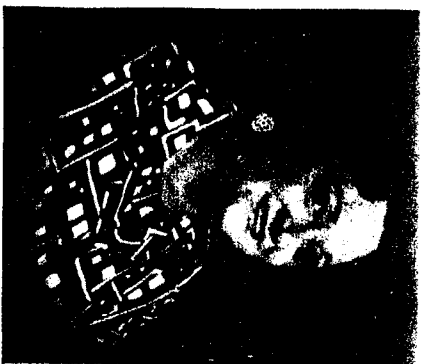

I, Annie R. Patterson, of Winter Park, Fla., was born Annie R. Edmonds De Rothschild in Greenwood, South Carolina. My aunt and uncle reared me. Emma and Case Henry Edmonds. I was reared in South Mills, North Carolina where I entered school. I graduated from South Mills High School, South Mills, in 1932. Prior to graduation I had received my elementary teacher's certificate in religious education in summer workshop under the guidance of Rev. George P. Harrell, a professor of The Southern Baptist Theological Seminary in Louisville, Kentucky. I was reared quite religiously in that during my childhood I attended the classes in summer school to acquire my four certificates in Baptist Young People's Union work... (B.Y.P.U.) Upon graduation from high school, I went to Norfolk, but no teaching positions were available. I took a course in cosmetology when I became a beautician. I went to California when married. I taught Sunday school there in the North Park Baptist Church, San Diego, California. Too, I worked as an economist for Klauder, Wagner and Company, wholesale food distributors, selling Point Loma, Silvergate and Pay Day brand foods. I decided to continue my education. I enrolled in San Diego State College. I attended night school part of the time and day classes contingent upon my working days or nights. Los Angeles (U.C.L.A.) graduated from U.C.L.A. in the 1938-39 class with my degree in economics.

In later years I have traveled abroad and reared one son.

During the past several years approximately fifteen or twenty I have been in business financing I represent private capital in both the United States and foreign countries. I was born a national and international financier.

I have been active in the Harry Byrd Machine in Virginia during the lifetime of the late Senator Byrd. I have been active in politics both in Miami Beach, Miami and Norfolk as well as international politics.

I campaigned for the president Mr. Richard Nixon in the Miami Beach, Florida area. I was registered with the headquarters of the Nixon campaign in Miami Beach. I worked in the victory drive one special Saturday.

I interceded with China in behalf of the United States and to bring a cessation to the war.

Above all else, I served five years in a Mexican prison for no other reason but that I confiscated the nuclear films showing the farce of the Missile Settlement but none dared accuse me to admit there were such films.
