join Minutemen - KC - 1966. 6 months  
 later approached by FBI agent to send him mail  
 got from Minutemen. Oliver did this + then lost  
 interest in M.M. Later approached by SA Stanley  
 Jackson, who wanted him to get more involved with  
 M.M. Then asked him to join M.S.R.P. Jerry Ray  
 then living with Storer. FBI Jack Jackson wife +  
 child at farm in Mo, where met Ray + people from  
 St. Louis. Met Jerry about 1971. Oliver's wife  
 name "Phil", Jackson's "Lee Sudman?"  
 Oliver wrote reports. Oliver had PO Bay <sup>to send to</sup> Stanley  
 lived near Oliver. He would go to Oliver's  
 house + edit reports. Where Jerry had said  
 both that James did + did not kill King  
 Storer had been delete all other references to  
 had Jerry only as pulling trigger. Stap  
 These reports are reason HSCA "talked on  
 the air Jan/Feb. 1978"

They were not listed in this report,  
 which Storer had edited before Oliver mailed to PO  
 Bay

In 1973 relationship with FBI terminated. I did not hear from them again until this year, in January 1978... "I got Haggerty, who had met with Johnson, a. told him about HSC of that investigation would be calling on me!" (Did not ask him in advance) Haggerty told him the committee had figured out that "Phil" was O.P. I had wrote FBI and told them I wanted no part of it, that they had gotten me into it... "Two weeks later I looked for me and why men" & <sup>P. Beets</sup> "They showed me a prepared report that I had made in 1971 about Jerry, etc. asked him to sign a release for FBI material, asked him to be informant for them, he said no but they got him to agree, while on parole in Florida, to stop off at the office - Jerry, Stoner & Fields. Accompanied by Donna Stayton, Mary & Dorothy, HSC asked him to try to get hair samples Jerry, Stoner, Fields. Got from Baugh from Johnson MSR P Haggerty Took videotapes in Maricopa which Pete Beets picked up. Something from Se. Ill. State Univ.

31 His appearance just faded because he was in hospital. Went down to Manhattan & came back with Jerry middle April, FR to Jerry.

Batz at his house frequently I hear tapes conversations on microcassettes, which Batz provided & replaced when he took them. Batz monitored most of conversations with Jerry but I hear would not ask Jerry obvious leading questions.

at this point now & he seems to start over again, about half way through first side stayed in contact with Jerry & Homer made reports, in 3rd person. Signed each page "Phil" (say FBI) relationship terminated 1973 or 1974

4) Bantz prepared lesson tapes of caught  
Eberhardt & Westman know of tapes  
When he asked to see OP OP called Bantz, who told him  
he knew whole story. Gave OP 3 alternatives  
Dis appear; Nonq variation; hold press conference  
to public  
Memphis, FBI told committee to be retaliation  
against OP by Jerry Ray through friends

Two agents FBI at OP's house 6 p.m. that day:  
Dennis McHarris & partner, who told of threat as  
being other woman, Clarence — + (not FBI)  
had heard from HS Lt

Next day, Thursday, Bantz said OP would hear from  
NY Times, hold out on Monday. Give name of phone  
no by HS Lt. Bantz told him what to say at press  
conference in Times. Arranged to meet Bantz at HS  
shop so someone else would see Bantz. Bantz told him  
to say some homo, punks, Raoul helped Raoul imagine  
from not to tell of his committee association, that he  
had "paid commissions, etc as patriotic citizen & was  
going public because I was fed up with the way  
Jerry Ray was lying". That some was only trying  
to sell his book & that he "got up with Duke Gregory  
just (a only)" because it helped sell books

Supposed to meet a couple at restaurant. Man had legs  
van which they saw & he got into. They saw his notes  
& that he was with someone.

Met Lane on Sunday - "girl named Tina was  
with me."

Lane confronted him with what he had & asked  
him to tell him what committee was up to.

Friend of woman with lane. All went to his house.  
Barty called. He typed Barty. First that there was a  
Sniper Press conf. on Monday. (Referts had never  
agreed to press conf) called back hour later. Pope had  
died, to wait a day. Horvok had been told to call OP  
on Monday if no one had called him by <sup>then</sup>

Met Barty in restaurant that night for details  
of what OP would say. Barty little concerned  
with lawyer-client relationship - on questions  
to ask Lane & Papiney

8/16 They had meeting. Photoy across street.

Barty called again - hysterical. Later called  
again to push for press conf. with Times.  
One more contact that night. Horvok called

next p.m. "They" had given him my name.  
Lid Horvok on. He said they'd fly in, that he  
was not coming, another would be in that day
