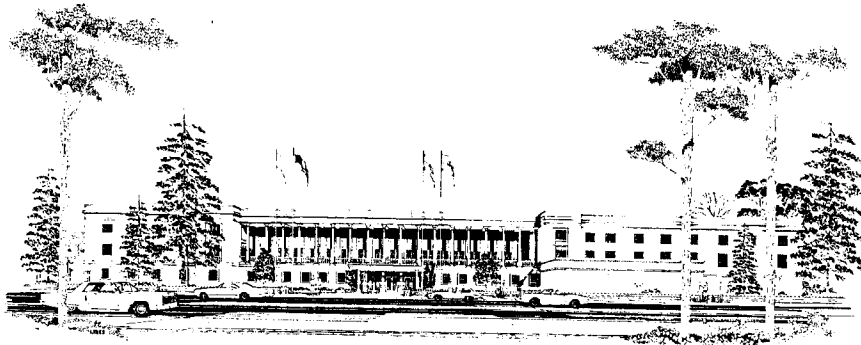

THE POPKIN PAPERS, WHICH CLAIM NEW EVIDENCE IN THE MURDER OF PRESIDENT KENNEDY, WERE HAND DELIVERED TO THE CHURCH COMMITTEE AND THE U-S ATTORNEY GENERAL'S OFFICE TODAY (YESTERDAY). IT'S NOW A 12 YEAR OLD QUESTION. IF LEE HARVEY OSWALD DID NOT KILL PRESIDENT KENNEDY, WHO DID? PROFESSOR RICHARD POPKIN:

INSERT - "AND HOW IT WAS DONE"

IN POINT OF FACT, MOST OF DICK POPKIN'S NEW MATERIAL IS NOTHING MORE THAN OLD MATERIAL GREATLY EXPANDED AND UPDATED. I REVIEWED IT ALL THOROUGHLY WITH HIM RECENTLY AT HIS HOME IN LA JOLLA. POPKIN'S PRIME PLAYERS ARE RICHARD CASE NAGELL AND LUIS CASTILLO, NAMES NOT UN-FAMILIAR TO SERIOUS RESEARCHERS. NAGELL IS A SELF-STYLED DOUBLE AGENT. CASTILLO WAS ARRESTED IN THE PHILLIPHINES IN 1967 FOR HIS ALLEDGED INVOLVEMENT IN A PLOT TO KILL PRESIDENT MARCOS.

POPKIN'S SCENARIO ASCRIBES AN "A" PLAN TO KILL PRESIDENT KENNEDY TO NAGELL AND FOUR OTHER MEN. AMONG THE FOUR IS THE "REAL" LEE HARVEY OSWALD AND AN OSWALD LOOK'ALIKE, A THEORY THAT DOVETAUIS BEAUTIFULLY WITH A BOOK THAT POPKIN WROTE IN 1966 CALLED "THE SECOND OSWALD". ACCORDING TO POPKIN, NAGELL DECIDES TO PULL OUT OF THE SEPTEMBER ~~1963~~¹⁹⁶³ PLAN AND DOES SO BY WRITING A STILL UNFOUND LETTER TO THE LATE J-EDGAR HOOVER, AND THEN GETTING HIMSELF ARRESTED. EVENTUALLY NAGELL FINDS HIMSELF IN A FEDERAL INSTITUTION UNDER "OBSERVATION". OFFICIALLY, THE WARREN COMMISSION DUBBED THE NAGELL STORY "WILD SPECULATION". BUT, ACCORDING TO POPKIN, THE DEMISE OF THE NAGELL PLAN PUT THE "B" PLAN TO KILL KENNEDY INTO OPERATION. ENTER LUIS CASTILLO WHO CLAIMED UNDER HYPNOSIS AND SODIUM AMATOL THAT HE WAS ONE OF AT LEAST 7 GUNMEN IN DEALY PLAZA THAT FATEFULL DAY OF NOVEMBER 22'ND 1963.
