I do hear from older people, too, but most are young.

In the mail with your letter was one from a man in Singapore who will send my books to his father in Australia who is 86.

If you ever have a picture taken of that fine painting, I'll appreciate a copy.

But do not, please, make one just for me.

All of my records will be a permanent public ^{archive} archive at a fine small local college, Hood College. It was originally a woman's college of 100 years ago. It is still largely that. And that picture would be in it for others to see in the future.

It may also interest you to know that in the same mail was a letter from a retired FBI agent who said that after Reading Case Open he believes that Oswald did not fire a shot.

And to date I've not heard a peep from Posner or his publisher.
