

Additional memo, conference with Col and Mrs. L. Robert Castorr, 5/6/67

DRE meeting Sunday night, October, Lakewood area.

White Rock Lake meeting on TV about 9/15/67. Machann there. One Rodriguez ~~if~~ charge sale tickets. Probably Dr. J.R. (not medical). Lived Hudnell St., off Lemon, prob. add. 3305.

Ice cream parlor man (see below) lots publicity. Had 100 Cubans working for him. Left suddenly for Puerto Rico.

Raised several thousand dollars. People there from far away, inc. Venezuela and Puerto Rico.

Castro
A man whose description is close to the FBI's of Hall seems to have been with the Student Directorate group, and with the October meeting, following which there was a meeting at Ed Schville's house (of leaders student group). Schville called Mrs. Cez next day to say "students" were leaving. They had been brought by Dean P erkins (name, not of school). Really, "these two" were leaving next day. With them was Sarah Castillo and a "beautiful, brilliant" girl from Florida, presumably Miami. She or Sarah Castillo late 20s. Sarah live parents on Hudnell St. Sarah head DRE Dallas. Worked "Ports of Call", series of related restaurants and Chagovelle Club, which was part of it. Her father Jose or Antonio. Ed Schville heard them say they were to go elsewhere (Ft. Worth?) to raise money, medicine, then go to Florida. Their abrupt departure not because of unpleasantness with Schville but schedule. He had, however, invited them to his home to offer them the books he said were used by Castro when he was a student in Mexico and he seems to have been outraged by their indifference to this, which he, by whatever reasoning of concepts, believed an important thing at which they should grab. They apparently thought him some kind of nut. He made pointed comment to Mrs. C that these "students" "had no expression on their faces" when they heard him make the offer. Of the pair of men, the larger one was the talker. This was the day after the Walker meeting.

Antonio Alentado- accountant: wife architect.

Larger man fits description receding hairline, etc as I read it from 11H383. Sarah Castillo's brother big man. Dark complexion, not olive. When I read description from 11H387 Mrs. C agreed and tapped her head on both sides near the middle, as though indicating the location of the recession or the billowing of hair around it.

Secondman not tall. Mrs. C. saw them also at Sarah's one afternoon. Confirmed 11H388 that he "made a television appearance".

Mrs. C heard the story that the FBI did not believe Sylvia when she talked about people looking like Mexicans and not Cubans and the agents took her into the street where she ticked them off, "that's a Cuban", "that's a Mexican", and astounded the agents by being right. They tried to get her to say not that the men were or seemed to be Mexicans but were Cubans.

"Beautiful, brilliant" girl probably Anna Diaz-Silvera. There is no doubt of Mrs. C's reaction when I said Anna. It was positive. Anna DRE Miami. She was with these men, something not indicated in the FBI reports, which do not even indicate questioning that might have revealed whether anyone else was with them.

Odio cousin of Marcelle Insua, whose father (dead) had been director of Cuban Dallas resettlement. April 1965, Easter Monday, Cuban Catholic Committee, Lakewood Bldg, Dallas, was destroyed by fire. Both C's indicate mysterious cause. Also indicate possible mysterious cause Insua's 12/64 death, although he had been hospitalized and had failed rapidly.

Insus had had important position with power and light co in Cuba. Even after astro he drove with a chauffeur only. The story is that the wife heard from the Chauffeur that her husband was to have been sent out of the country, allegedly to Siberia, so he feigned illness to pretend necessity of trip to doctor Miami, where Marcelle had actually had a serious operation. This is an improbable tale. Marcelle had had fancy shop El Nacional (where Mike McLaney ran casino). Mechann selected Insua to run relief. Near home Hector Izquierdo (right), 6255 Oram St. Wife to Mrs. C "terribly attractive person". She worked at Nieman-Marcus in special capacity, where she would spend considerable time with big-spending Latins when they came to Dallas to spend. Inq's in Dallas before 10/62. The Monsignor at Ursula We knew them well.....International Club in Dallas (do not recall why noted).

Mrs. L.C. Connell (pucille) "peculiar person" and close to Marcelle who was close to Mrs. Robert Light. Connell flashed lots of money, rolls of \$100.00 bills on Sylvia. She had trouble with her husband, possibly over her money. Cubans astounded at Connell separation, thinking them idea and close couple. Johnny Martino had known senior Odios in Isle Mines. Mrs. C. saw Sarita Odio crying as Martino spoke. Sylvia probably not at Martino meeting, Mrs. C thinks....Inference Connell's activities were calculated to divert attention from and interest away from herself.

Next to Mrs. Castorr at meeting was Scorgio Mancito, who started to make a speech when someone entered room and he turned white, became confused and entirely speechless without being ill. Mrs. C strong recollection. Connell, Alentado there. Mrs. C perplexed, wondered why this happened to a healthy young man. It is her belief the reaction is connected with someone he saw enter meeting, causing him great fear. Father Mechann there. Early 1963, poss Jan-Feb. At Walnut Hill Recreation Ctr. Mrs. C made arrangements, provided coffee, cookies, promised to empty hall by 10 and was worried at endless chatter which was running too long. Walnut Hill Lane. Mancito lived address from Alentado (Lennon Ave).

Strong inference Connell CIA from Mrs. charge from Colobel. She changes hair, from grey to other colors. Buck teeth, Episcopalian.

Grill in Cuban Catholic office. ^{Both 1's} unusual name. Thought it unusual that those Cubans resettled from Miami were classified as to whether or not had been political prisoner.

Thinks Luis Angel Castillo had been in Dallas. Felt this soon as she saw picture in paper when story broke in ^{Miami} ~~Washington~~, and thinks he may be Sarah Castillo's brother, but had no reason to believe this, never having seen or heard of second brother. The brother she knew older than this man.

The "hospital Cuban" of Rowley's letter of 5/5/64 may be one Sanchez, whose career seems to parallel it his. Another possibility is Sanchez's friend Rodriguez. Both were among the many Cubans working at the hospital. Sanchez went to Miami apparently to go on relief and get out of Dallas.

Heard a year ago Mechann working for mental health organization. Supposed to have visited Guitart. She started to talk about Guitart and stopped, without returning to him. My impression is that she has some question about him.

When Odio convalesced she received letters from Connell, left behind. From Boston, where Connell has son who is doctor. Psychiatrist or Psychologist. Told about taking priest (Mechann?) to part of Boston waterfront so bad he was frightened and removed collar (1964). The man who arranged Sylvia's convalescence (phon) "Ferray". Suggests man in False Oswald reports, Ferrae (error, Ferrer). He is wealthy Puerto Rican apparently involved in moving her to Miami. The people with whom Sylvia stayed

named Rogers. Son of Texas Industries Rogers-cement, etc. Mrs Rogers found letters, gave to Mrs. Castorr who gave to Lt. George Butler of Dallas Police.

In the letters Mrs. C says Connell seemed to play a mysterious role and to say how nice it was of husband Lee to let her go on trip. It is Ferree(?) who was trying to sell his ice-cream plant to Tammya (see letter).

Rumor Machann had been drugged or gotten drunk and framed into a bedroom scene with Sylvia who said nothing had happened, ^{(in the Connell home, allegedly by Mrs. Connell (Lake Shore Blvd). Also story that she slipped and beat Machann.}

Machann saw TV reporting assassination, disappeared from home of parents and was hospitalized small hospital where he allegedly got shock treatments.

Girl who had been close friend of Marcella Insua in Cuban resettlement-tewdry - purple lipstick, overly exaggerated large hats, etc, described as lo king and acting like streetwalker. She said on phone one day she had some "fantastic" information about assassination. A man offered her \$50,000 to say what she knew. Met Mrs. C in Big Boy restaurant. Mrs. C gave info to Butler, all of it, taking couple hours. Woman went to Butler home, Mrs. Butler wanted no such in home. Butler could not understand that she had anything. Woman Mary Ann Raynes (Phon Raymiss?), supposedly madly, vocally, in love Machann. Not a Cuban. Desperate to find Machann when he left Dallas. Husband connected with bull club. They were separated and got together again when he went to Chicago. Boy girl's friend was a Miss Light (phon) who had 6 or 8 children. Husband, Robert, pilot. Mrs. C took Mary Ann to Butler home and Butler took over. Many, many calls, meetings. Butler frightened, feared frameup. He seemed to think she had nothing. Mary Ann always referred to "the government".

Insua told Mrs. Castorr he had no idea where Machann was, and also that he could not understand why the church in Miami forwarded Machann mail to him in Dallas, when they knew he wasn't there (not Miami SS report on McKann).

Machann needed help and went to four high church officials unsuccessfully. They would have nothing to do with him. He left his parish 10/29/63. He left letters for parents, Insua. He saw Insua at office as he was about to leave but did not speak, outsider present.

Some mystery about Machann's car, small, foreign, poss Volks, according to C. But she doesn't know what mystery is. Connects Mary Ann's name.

Butler told Mrs. Castorr that night 11/25/63 back Ruby answered police dept phone. Call from B of J.

10/1 Town Hall meeting with Martino, Machann, Mrs. C on stage, coincided with "students" meeting bank building out in Farmers' Branch". Some two men, one made speech disturbed to find it being taped, demanded tape, threatened to use karate (claimed brown belt) in unsuccessful attempt to get it. These tapes were duplicated and sold as means income. Taping done by Irving man who, with his wife, are chiropractors. Speaker (again strong suggestion Hall) said JFK was coming to Dallas couple weeks and "We'll get him, one way or another." Name chiro phon Reader (Reader) of Rhodifer. This study group was small.

Elderly man who had been WW I sub commander, Glen Myers, wanted to give unneeded household items to Cuban relief told Mrs. C he was running guns to LA at \$5.00 profit each. He also had owned interest in hotel on Isle Pines. Tied to Murchesons. Lived on Meadow Road (could false Oswald people have left trailer with him?), in Nor Dallas, just off Preston.
