MARIA PULTS - VICTIM  
EXTORTION.

The following investigation was conducted by  
SA E. CLEON GLAZE:

AT SAN ANTONIO, TEXAS

This investigation was predicated upon receipt of a telephone call from MARIA PULTS, 215 Wonder Parkway, San Antonio, Texas, on November 30, 1963, advising that she had received a threatening letter in the mail from an unknown individual. She said the threat was to kill her because she offered aid to the family of LEE HARVEY OSWALD, accused assassin of President JOHN F. KENNEDY.

Mrs. MARIA PULTS, nee Dowhan, was interviewed at the home of ROBERT A. PULTS, 215 Wonder Parkway, San Antonio, Texas, and she advised the following:

Mrs. PULTS stated she was born February 19, 1926, at Vinnitza, Russia, and married ROBERT A. PULTS in June, 1947, in Germany. She said they were divorced at Ciudad Acuna, Mexico, August 20, 1962, and she subsequently married JIM DENCER at Comfort, Texas, November 15, 1962, and divorced him at San Antonio, Texas, November 14, 1963. She said she has been living with her first husband, ROBERT A. PULTS, since her divorce from DENCER.

Mrs. PULTS advised that she went to Dallas, Texas, on November 26, 1963, and volunteered to give aid to the widow of LEE HARVEY OSWALD, accused assassin of President JOHN F. KENNEDY. This offer received publicity through local news media which resulted in numerous phone calls and letters being sent to her. She said some of the letters and calls have been threatening in nature, but most of them have been to offer support and encouragement to her.

Mrs. PULTS made available a letter, the contents of which follows, and stated it is the only letter received to date actually threatening to do bodily harm to her.

"San Antonio, Tex  
Nov 28, 1963

"Mrs. PULTS

"I have just moved to this city from my former city of Dallas. I lived with my married sister there but after the disgrace of Dallas and its John Birchers and that lady that spat on

Mr. Stevenson a month or two ago and now this.  
 (Mr. KENNEDY) I came to San Antonio to live. Now  
 I read in the papers that you you are a communist  
 hiding under the name of an American name because  
 of your husband. You trying to get this Russian  
 women a home here. Lady please don't do that.  
 I will kill you, and plan to. (believe me) And  
 that remark, that you made about you don't care  
 what Americans think. You just better, care and  
 keep your dirty mouth shut or go back to your  
 dirty Russia. (Mr. Walker in Dallas and that  
 women there are on the list that will be  
 taken care off too. We already have to  
 much of kind here and all over the world,  
 and now is the time to dispose of this trash..  
 (over).. You and Walker and that women in Dallas  
 will have \_ go.

"P.S. There are no finger prints of mine on  
this letter."

Mrs. PULTS said she has no idea who may have sent  
 the above stated letter. She said so many people are opposed  
 to her offer to aid Mrs. OSWALD that it could have been  
 sent by any of those opposing her. She added that the  
 handwriting was not familiar to her.

Mrs. PULTS advised that since about November 26,  
 or 27, there have been an average of 3 or 4 threatening  
 telephone calls each day. She said the phone is usually  
 answered by one of her three children. She identified  
 the children as MARY ANN, age 15, JANE MAE, age 14, and  
 ROBERT A., JR., age 13.

Mrs. PULTS advised that several people had handled  
 the letter since she received it and could not be sure who  
 all of them were. She estimated it had been handled by at  
 least 10 or 12 persons. She stated that she would protect  
 any future threatening letters received by her from being  
 handled by other people.
