 - These remain the basic books on the JFK assassination. They also report the first and most thorough and extensive resurrection from suppression of the officially ignored evidence, reproduced in facsimile in all the books.
 - **FRAME-UP** and Weisberg's subsequent investigations laid the basis for getting the assassination of Dr. Martin Luther King, Jr., in court by providing a defense for James Earl Ray.
