You ask about Walt Brown's books. Frankly, they are worse than useless, judging from the one I read, because he is, despite his pretenses, a subject matter ignoramus.


With regard to citation of the Report, all my references to it are to the pages of the official copy. Now it was reprinted by photographic reproduction of the pages of the official report by Walden Books. I understand that Walden was bought out by Borders. But any bookstore there that handles United States books should be able to get a g copy if any remain.

The advantage of getting that one is that all citations to the official copy will be identical with what you find in it.

It is possible to have questions about how the Paines conducted themselves, but I think that is just the kind of people they are and that it has no real significance.

There is a dealer in book remainders named Hamilton, located in the State of Connecticut. He may have a copy of the Report. Again, if you have a store that deals with United States books, it should know of Hamilton.

I have received my copy of "Whitewash: The report on the Warren Report", for which I thank you. As you did not say otherwise, I take it that the amount of monies I sent was sufficient.

I would like a copy of "Post Mortem: JFK Assassination Cover-up Smashed", for which I enclose \$30.00, I hope that will suffice.

Further to my suspicions concerning Mrs Ruth Paine - her concern for Marina Oswald, and for Lee Oswald, does seem to be, (or was) unduly generous. Also her behaviour on the 23<sup>rd</sup>, (the day following the assassination) I think was rather odd; leaving her home while it was in the process of being searched. Also her apparent willingness, (over willingness possibly) to allow her house to be searched on the day of the assassination, although to be fair she probably had no choice. There are other aspects of her character, since the assassination, which does not, (to me), seem to conform to my idea of a Quaker.

However, probably it is that I am sceptic!, I am suspicious of most things! At this point, it would be appropriate to thank you for your indulgence, concerning my observations(?), thank you. Could you comment on Walt Brown, and would recommend any of his books?

What I am hoping to do, is compare findings in the hearings, and how they were interpreted, (mis-interpreted would probably be more applicable) in the "Report".
