Dear Mr. Read,

Please excuse this delay in responding to your undated letter the envelope of which has an illegible postmark. After three months in the hospital and so-called nursing home I'm feeble but home and three mornings a week are taken up with kidney dialysis. In addition, we both have other medical appointments so I've little time. However, I do respond in the haste I hope you'll excuse.

When my wife fractured her hip I gave Hood College, here in Frederick, pursuant to an earlier agreement, all the remaining stock of the books that were published. They can provide any you do not have. None since NEVER AGAIN! *They'll also get my files.*

The Russian files on Oswald greatly exceeded the volume they gave Clinton. They know the US did not ask for them at the time of the investigation and they were not about to embarrass this government by disclosing what could mean anything. If it exists. Blakey, as usual, smells like an overused and undercleaned barnyard. He had no "intelligence" on Oswald's alleged threat to kill JFK. That was in an FBI report from an anti-communist informer it had inside the CP, a man anxious to do something about and to the USSR. He was a sinister liar who could have set the world aflame with his lies.

Also, have you any information relating to the Russian files on Lee Harvey Oswald, which were handed to President Clinton by President Yeltsin, at a G8 summit in Cologne, earlier this year?

In March 1979, Drs. Hume, Petty, Boswell and others were interviewed by the House Select Committee on Assassinations, (the second session).
