It cannot withstand critical examination, not even the Report itself.


As I think you will see in my first book, which dates to 1965.

THANK YOU FOR THE QUICK RESPONSE AND ESPECIALLY YOUR PERSONAL LETTERS. I AM WRITING AGAIN TO ORDER "WHITEWASH II" & "WHITEWASH IV," I FEEL RATHER SILLY THAT I DID NOT ORDER THEM A COUPLE WEEKS AGO WHEN I ORDERED THE OTHERS. HOWEVER, YOU HAD TROUBLE OBTAINING INFORMATION BECAUSE OF BUREAUCRATIC ROADBLOCKS, I HAVE A SIMILAR PROBLEM WITH MY WIFE. NOT SHARING MY INTEREST IN THE JFK MATTER, SHE WOULD NOT APPROVE FIVE BOOKS AT ONE TIME.

I HAVE JUST BEGUN READING "WHITEWASH" SO I HAVE NO REAL THOUGHTS OR OPINIONS YET. AS I HAVE MENTIONED, I (SO FAR) HAVE TAKEN THE "OSWALD DID IT" STAND. THIS IS NOT ENTIRELY BECAUSE OF THE POSNER AND MOORE WRITINGS, BUT "THE WARREN REPORT" IN ITSELF TELLS A CONVINCING STORY. A STORY YOU WRITE IS TERRIBLY FLAWED; PERHAPS AFTER READING YOUR WORK, MY ATTITUDE WILL CHANGE. I PERSONALLY THOUGHT MOORE'S

SHOOTING SEQUENCE WAS MORE PRACTICAL THAN POSNER'S, DESPITE POSNER'S BELLS & WHISTLES PORTRAYAL. I CAN NOT COMPREHEND A SHOT AT FRAME 160. I BASE THIS THOUGHT ON THE FACT THAT BY FRAME 190 TO 210 (WILLIS PHOTO #5) THERE SEEM TO BE NOTHING GOING ON IN THAT PHOTO. AS I WROTE TO MOORE, IF YOU "POP" A BALLOON IN A CROWDED ROOM - SOMEONE IF NOT EVERYONE WILL LOOK TOWARDS THE "POP". YET IN WILLIS PHOTO #5, WHETHER THERE WAS A GUN SHOT, FIRECRACKER, OR BACKFIRE TWO SECONDS EARLIER SOMEONE SHOULD HAVE TAKEN NOTICE. I DISCOUNT THE BACKFIRE. AT LOW RPM'S A MOTORCYCLE OR VEHICLE'S SO CALLED BACKFIRE WOULD BE MORE OF A "POOF" THAN THE BULLWHIP CRACK OF A GUN SHOT. A FIRECRACKER THROWN NEAR THE PRESIDENT OF THE UNITED STATES WOULD, OR AT LEAST SHOULD, HAVE CAUSED A FLURRY OF LOOKS AND/OR ACTIONS. FOR THOSE REASONS I FEEL THAT NOTHING HAPPENED UNTIL AFTER WILLIS SLIDE 5.

I HOPE I DO NOT INSULT YOUR REMARKABLE WORK AND
