Thank you for responding to my last letter so promptly and so courteously.


In regards to the Mexico City CIA tape you wrote:

Your letter of the 23th reminded me that someone had made the same request some months ago, that I'd written him and ~~thought~~^{thought} I'd left the letter unsealed so I could add to it after making a search. I looked for it, found it, found it was addressed to you, so I opened it to insert this.

I was not able to locate that record. I searched the file I have on Heitman and it is not there and I cannot remember the Congressman's name. It might be there.

I have a clear enough recollection of the record to be certain it cannot do what you now say, help your ongoing research on that tape.

The FBI has it and refused to disclose it in my FOIA suit for the Dallas records. The court supported them in their claim.

The FBI has the contents of that tape and the same is true of it,

They first sent a teletype from Dallas to HQ, HQ asked for a transcript, that was sent, and again the court refused to compel disclosure.

If you are able to ~~make~~ develop anything other than theories or conjectures I'll be interested.

At the moment I'm preoccupied with preparing for some filings in court on which there is a close deadline and I can't make any searches.


But I will as soon as I can, possibly next week, depending on how I feel then.
