Dear Dr. Robison.

Your request of the 13th, a simple one, by unusual coincidence is one I cannot fully satisfy. I mislaid the clippins I had of the statement, a very unfortunate one that may have been taken out of intended context, Chief Justice Warren did make.

I used it in my first book, WHITEWASH, and have not been able to find it since. It, really they, for there was more than one clipping and a few editorials, besides the news reports, is simply misfiled and Inhave not stmbled accross them since.

However, I am confident he did not make the statement in Dellas, but in Washington, and is either the first or one of the first he made after the Commission was established.

Only he knows what he had in mind. One possible interpretation, if one finally learns the applicable regulations covering the executive agencies (not his commission) is that he had in mind regulations restricting the release of investigative reports, as of the FBI.

Usually he enswers no meil.of the Co mission. I am told he doesn't read it, having detached himself entirely from it.

May I make two suggestions? The New York Times index should disclose this. I'd begin checking or having the check made for the last week of 11/63., I think it was in early 1964. Another is to phone the Texas State Archives (as I recall, the name of the man with whom I was in correspondence is Tay) to see if the man in charge of this archive can sumply the statement or the date. This would not have been part of the Texas investigation, but they may have kept relevant clippings.

Sorry I can't be of more help. Ordinarily, I could lay my hands on such material promptly.
