Dear Dave Roberts,

I do try and answer every letter, but it shortens the already short nights.

On the Altgens picture: it is the property of AP, Rockefeller Center, NYC. It costs \$15.00 for reproduction. I do not know the cost if you will not print. If you had one of the original editions of WHITENASH II, the picture would be on a double page that is about 9 inches wide. The last page has an enlargement of the man in the doorway about 5 inches wide. The inside back cover has two pictures of Lovelady taken by the FBI and one of Oswald in the jail, in that shirt. On the inside front cover is the picture of the man on the fire escape and the open window. If one of these would do, perhaps we could make you a special kind of deal. The book sells for \$5.00, but for school purposes, if it is not too late (just got back from a trip), send us whatever you think is fair that you can afford. You'll have to take the Altgens picture out carefully, though, not to ruin it for it is on two pages.

Altgens used a 35mm Mikkorex, 105 lens, Triax film. That's something the Warren report doesn't have.

I was in New Orleans. Mark was not then working for Garrison. He seemed to be taking it easy. Perhaps he is writing again.

There is more information on this in PHOTOGRAPHIC WHITENASH, one of my newer books. It tells the story of the suppression of the pictures (flyer enclosed). Mrs. Lovelady phoned me just as the book was being printed to tell me that her husband had not worn the shirt the FBI said he wore that day, that it had a large red and black block pattern. We have found him in that shirt in a suppressed movie. I do not think it can possibly be the shirt on the man in the Altgens picture. That makes it a little more exciting, I think. Bill has one. Or do you now know?

Please tell Bill I got his letter and I thank him for his courtesy. I really haven't time to write more. I think he'll understand. My best to you both.

Dear Dave Roberts,

Please excuse the delay in answering your requests of 12/19. I was in New Orleans for 10 days.

I must disabuse you. I really cannot recite the 26 volumes by heart. I have a pretty fair knowledge of their content, but it is not by any means complete or as complete as I'd like it to be. It is a pleasing flattery, no more.

It has not been so many years since I was your age, interested in more things than I could finance, and going without lunch in a vain effort to keep up with them all. I know your problem. Therefore, your remittance pays in full for the following: Two copies of WHITEFLASH II, one with the Altgens picture cut out for you, the other autographed; one copy of PHOTOGRAPHIC WHITEFLASH, also autographed. These were slightly damaged in the mail. You may want to cut other things out of the book from which I have removed the Altgens picture.

I have not fastened the two pieces of the picture together, nor have I removed the caption, because I do not know how you will mount it. Perhaps the easiest way is by use of Scotch mending tape. If you are not familiar with this tape, it has the advantage of sticking better and becoming virtually invisible. It has the disadvantage of tearing paper if you make a mistake. So, if you place the two pieces carefully, handle the tape carefully, you'll have no problem. After you have mounted the picture, if that is what you intend, rub the tape with a flat, blunt object, like the back of a letter-opener. You will find that when all the tiny amount of captured air is forced out, the tape is close to invisible. One warning: if the tape has had the sticky side exposed for a while, it may have picked up some invisible dust that will show black after it is applied. If it is a new roll, this is no problem. But, if it has been exposed for some time, remove the part that has been exposed first.

The newest book is OSWALD IN NEW ORLEANS: CASE FOR CONSPIRACY WITH THE CIA. That is published by Canyon and is available at most stands. Price: 95¢.
