MISCELLANEOUS - INFORMATION CONCERNING

Inspector JAMES R. MALLEY called at 6:45 P.M. and stated that the Commission had now decided to make the pictures they previously referred to on this Sunday. He said some of the people would start arriving early Saturday evening.

He wants us to:

1. Arrange for Dallas Police Department to handle the traffic on Sunday.

2. He wants a surveyor.

3. He wants TRULY to have the place available on Sunday and very possibly SHANEYFELT will come down tomorrow and probably will want to look over the School Book Depository on Saturday.

He stated that the Secret Service was going to fly the car in on Saturday and keep it out at the airport, but after they make these pictures with the dummy, then they want to have some closed garage where they can go without anyone seeing them. He wanted to know if there were a garage in the basement of the School Book Depository building. I told him that to my knowledge, "no", but that we could probably arrange one some three blocks away in the Texas Bank Building.

He suggested that they would probably want an agent about 6'2" with Governor CONNALLY's build, and one

about 6'½" with KENNEDY's build, if possible.

He advised that Secret Service is bring a package of walkie-talkies, six in number. I told him I knew we had four of these.

They will want the following rooms for Saturday night, all singles:

JIM MALLEY
THOMAS KELLEY
ROBERT A. PRAZIER

He stated that he believed SHANEYFELT and ROSE were coming down on Friday and maybe an Agent named TRIPLITT would be coming with them.

He stated that he did not know when the Commission people were coming in and it would not be necessary to meet them, but we would tell them where they had rooms and apparently they want them at the Sheraton. KELLEY and GAUTHIER will come in Saturday afternoon and he will let me know.

When discussing this matter with Chief CURRY, we are to tell him that we would like for it to be kept as quiet as possible and no advance publicity on it. Same will start about 6:00 A.M. on Sunday.

Mr. MALLEY stated that he had volunteered the FBI Office for a conference with all personnel involved at 8:30 P.M., Saturday night. I also advised MALLEY that we will have an Agent on Saturday night and Sunday that can be called. I asked him how many Agents he thought we would need and he did not have any idea but felt that four to five ought to be available.
