One friend who was able to spend some time at the Russell archive at Athens sent me copies of some of the records in it and another friend who is seeking to increase the scanty Cooper archive at the University of Kentucky sent me some from it. Both died refusing to accept that theory.

I underdtand that your brother has your father's records. If he or you or younr mother want any of the Russell and Cooper records I have I'll be glad to provide copies, with no strings and with silence about it.

We did not attend the Hood graduation because I feared feared that warthas Church or someone else might have thought to introduce us and I fear that might cause you embarrassment. Its centennial year it awarded my wone and me honogray doctorates for our work on the assassination. The awards singled out that we eschewed all theorizing and restwicted ourselves to the official fact. All our records will be there, some already are and students use the third of a million pages I got by a dozen FOIA lawuits. One just completed a fine honors paper on an aspect.

If your mother or any of you has an interest in why your father felt as he did, I refer you to what I regard I cannot send you, my current where NEVER AGAIN! I've been trying without success to get copies but as the publisher has made no single effort to promote it he has not responded to a number of requests for copies so I can send some faround. It will indicate some of the many areas in which the Commission Members were not told all its staff knew and other areas in which the executive agencies withheld from them.

This is particularly true about that single-bullt theory.

This is not the first time I've written of Specter as I do and it is not the first time I've accused the authopsy prosectors of perjury. I've not had a peep of complaint or protest from any of them. And I expect none.

But, your father's decubts are amply confirmed, the reason I send you the enclosed article and tell you about NEVER AGAIN!
