Dear Harold:

Thank you for the index to your new book. I will not need a copy as I will buy one myself when it becomes available here which I hope is soon. I have been busy of late and took a two week vacation. I have enclosed a copy of two articles that I have written about the trajectory lines on the postmortem skull x-rays as well as the bone fragments recovered after the assassination. I hope you find them interesting.

Since writing the paper on the pencil lines I have had an opportunity to talk to DR. Young who Ebersole said directed him in drawing them "for purposes of taking measurements for a bust of Kennedy". Dr. Young, who worked with Dr. Burkley, has no such recollection of this but does say it is possible that he served simply as a messenger between Burkley and Ebersole. Dr. Young was in the autopsy room the night of the autopsy but in my conversation with him I found no new revelations except for the fact that he reinforced that the adrenal glands were looked for and were not found consistent with JFK's known adrenal insufficiency state.

Another revelation which I have made which I hope will be held in confidence until I can request him is from Dr. Olivier. I called him because during his WC testimony he talked about drawing lines to get the correct trajectory through the skull for his experiments for the WC where he correctly aimed at a point just slightly above the EOP. He told me that he was briefed by Drs. Humes and Boswell and that they showed him the x-rays and a few photographs of the entrance wound in the back of the head near the hairline. What I need to do is call him back and see if I can pin him down on what exact time this was. His recollection was that it was very cold when this happened however the tests done on the wrists and goats was done in May 1964 just a few days before his WC testimony. I am suspicious that the skull experiments were done much earlier on before the SBT was dreamed up which necessitated his experiments on the wrists. Furthermore when you go back to the WC exhibits you will see that while the ballistic exhibits associated with the wrists all have dates on them the ones associated with the skulls have no dates on them. What is crucial about this is that if the skull briefing and experiments were done earlier than March then there will be further documentation of perjury on their part about not having the photos and x-rays available to them prior to their WC testimony and the creation of CE 385-388. In either case the fact that they briefed Dr. Olivier with some of the photos and x-rays still indicates that they perjured them selves later by saying

that they had not seen these materials before the 1966 DOJ Inventory. The fact that Olivier actually saw autopsy photos in 1964 was reinforced in our conversation because he said he was surprised to see so many more photographs when he saw them during his later association with the Rockefeller Commission. As I said I hope you can hold this in confidence until I can talk with Olivier again to pin him down on whether the skull and wrist experiments were done at separate times.

If you have any comments on my papers I would appreciate it. I hope things are going well there for you and I wish you well on your upcoming book.
