Dear Peggy,

I am not up to the kind of ~~like~~ phone call you made this morning and it is necessary that I avoid any like them. I simply am not <sup>up</sup> to them now, particularly my heart isn't.

So, first <sup>I</sup> got out the letter you objected so much and the first thing I find is that you misrepresented it. My exact words were that "you clearly have not thought through, your Junior G-Girl faith in the Baltimore police internal investigation, and what you may not be aware ~~of~~ that you have always done, apologized for it and justified it." I've added the emphasis.

What you represented I said is quite different from this. I am also sure that you made other misrepresentations of what you said I said in the past.

I had ignored the evil Livingstone is up to until I learned that he was going after Mary, of whom my wife and I are and have always been very fond.

Your phone call today justifies the effort I made in the past to get you to assess your emotional condition on all of this. It also assures me that you are unwilling and/or incapable of doing that. Which means that there is no point in making any other effort.

When this is all over, if you have <sup>an</sup> interest, you can see what I told you I had that you blindly and stubbornly, I used the word unthinkly, <sup>ignored</sup> ~~and ignore~~.

When I come back from the meeting I'll copy enough of the first page for you to know that I had written what I say I had and so that if you like you can see it in the future.

I got a letter from Mary today. It did not enclose Harry's letter designating me the

head of his imagined conspiracy against him. So, I cannot give them that useful as it would be when I am the complainant.

I am sorry that you have not once reflected giving an thought at all to what I tried to get you to think about. That would not in any way be of any use to me. I took that time because I think it is in your interest.

But when you so grossly misrepresented what I had written you I guess there is no hope. I'm sorry for you.

As you will see from my enclosed letter to Gary Shaw, today's appointment was cancelled over sudden illness. I'm glad, I was not in the best state of mind for it.

But after your tirade this morning and Mary's not sending me what you said she had, including Harry's wasting me in the role of chief conspirator against him, rather important, I think, when I am the plaintiff to be, I'm taking no more initiatives. I'll do what I can with what I've started and I'm not going to make any effort to get anything not offered voluntarily. There is nothing in this for me but trouble and I need no more of that.
