the original sources, the two school teachers, should be interviewed.

In the other case, a bankrobber who was convicted for 20 years in December 1966 in Los Angles is trying to wheel and deal his way out of jail on the grounds that he has information concerning the assassination, knew of the meeting where the assassination was planned, has documentary proof, and knows of two witnesses who have fled the country. (It is noted that above, drives a car with New York license plates.) He also says that the inform tion from New Wrleins "adds perfectly" with what he has.

This individual, has lived in various cities in Mexico and has fought in the bull ring as a bullfighter.

He refuses to furnish any inform tion unless reflected from jail and transported to Hexaco. He threatens to write the President and Attorney General.

Two of the three psychiatrists who have seen him in this regard feel that his information improbably fictitious. Another isn't too sure.

These two memos do indicate a cossible connection between information in view of the bullfighting assect, it might be easier to try to locate in Mexico or at least check with the two school teachers who talked to him.
