From both ends. You apparently know nothing at all about Howard Hughes, either.


Of how absolutely impossible it then was for anyone to see him.

Reference is made to my letter dated March 2, 1988, regarding your Freedom of Information-Privacy Acts (FOIPA) request, wherein you were advised that the Department of the Treasury, United States Secret Service referred material to the FBI to determine its releasability.

" Forty-five " pages were reviewed and enclosed are the four pages that were determined to be releasable. Deletions were made from this material to protect information exempt from disclosure pursuant to subsection (j)(2) of Title 5, United States Code (U.S.C.), Section 552a and subsections (b)(7)(C) and (b)(7)(D) of Title 5, U.S.C. Section 552. See the enclosed form 4-694a for an explanation of these subsections.

You may submit an appeal from any denial contained herein by writing to the Assistant Attorney General, Office of Legal Policy (Attention: Office of Information and Privacy), United States Department of Justice, Washington, D. C. 20530, within thirty days from receipt of this letter. The envelope and the letter should be clearly marked "Freedom of Information Appeal" or "Information Appeal." Please cite the FOIPA number assigned to your request so that it may be easily identified.


