Dear Mr. Weisberg,

Your six books on the JFK assassination have become a very important augmentation to my library. It was nice to receive them so promptly, and I was thrilled by your letter, discussing the issues, books, and personalities I had mentioned in mine.

The one that seems most important to the latest revived quandary (over the medical evidence) is **POST MORTEM**. Perhaps Jim and Jay have received some extra remuneration for their recent performances in the limelight. If they have they earned it. It must be nauseating to have to keep lying to the people about the murder of a President for a few decades. Your work exposes the finer points of what an absurdity we have in the official record. Someone armed with an expertise in these matters, such as you and Mr. Fensterwald accrued, could have taken these great medical men to task and embarrassed the hell out of them. But I don't expect it will ever happen. They'll be protected from that, assiduously.

About Dr. Crenshaw. I considered the idea that maybe he heard an impersonation of Lyndon Baines' voice on the telephone early Sunday afternoon while LHO was fighting for his life. Also, that S. S. records of the president's whereabouts and his phone log might have been altered to plausibly deny a couple of phone calls to Dallas on that weekend is not difficult to entertain. And Crenshaw would not seem to need to tell us a lie or terrible exaggeration in a purpose like selling his book. He's fairly well heeled and has avoided the topic for twenty-eight years.

The matter of Mr. Oswald's whereabouts between 12:15 and 12:30 still intrigues me. And the identity and clothing of the young man in the doorway are yet quite pertinent in the context. I'll be having need of another copy of **WHITEWASH II**.

In your 5/8 you mentioned the second Carolyn Arnold statement, written out during an interview with the FBI, and corrected by Mrs. Arnold herself. If you could possibly send me a copy of this document, it would send me into ecstasy. From HE 22, 635, I've made an acceptable copy of her short statement to SA Robertson about standing on the front steps with O. V. Campbell and her girlfriends from about 12:25. This is CE No. 1381. But I have failed to obtain the elusive CD 5, p. 41 and the handwritten thing you mentioned.


