"Reasonable Doubt" is a superb documentary now available in the stores, VCR cassette


It is on the magic bullet about which I went into great detail in my books.

My name is Beau Stricker. I am a good friend of Mr. Kevin Heling of Sheboygan. He was a student of Dr. Dave Wrone in Stevens Point. Mr. Heling told me that you were one of the members of the Warren Commission, investigation the assassination of President John F. Kennedy. He is one of my biggest heroes. 
