Dear Harold,

It was disappointing to learn from your letter copies of your latest book are not yet available. What are the prospects of early delivery? Is it reasonable to expect them before Xmas? I am concerned that they arrive before I leave the city for the winter at the end of December. Please let me know. Sylvia shares my anticipation.

When copies are available it would do you and your cause good to donate one copy of everything you have written to the Tamiment Collection which was formerly the library of the old socialist Rand School of Social Science at 7 E 15 St N.Y.C. but is now an integral part of the Bobst library of New York University on ~~W. 4th~~^{Washington} Square South in N.Y.C. If it would help I would ask Ms Dorothy Swanson, the librarian to ask you to make this donation to the collection which she is anxious to build up. I have already told her I intend at some future time to place my entire JFK assassination library - which is quite extensive - in the Tamiment Collection.

I have been in touch in with John Mouldes of the National Tattler, as you know from the oft copy of my letter to him which I sent you. By the way, why didn't you comment on my letter? Mouldes has answered promptly. He persists in his error about the importance of Ford's role on the Warren Commission. But he does say I have whetted his appetite about Dr. Buckley and he will look into it.

One item in Mouldes's letter is news to me. He says "Dr. Trowbridge Ford, a political scientist at Holy Cross College, has spent several years exploring a theory that John Kennedy's assassination grew out of a conspiracy involving Nixon, Gerald Ford, and others." Do you know anything about that? Have you heard of Dr. Trowbridge Ford?

I believe you are wrong to dismiss Weclit's "last" like you. I am dismayed and angry by Weclit's pusillanimous attitude toward authority and the establishment. But I also recognize that he has uncovered significant material. He has established that neutron-activation tests were performed by the FBI or at their behest on bullet fragments and the "magic" bullet in the JFK assassination, with the unmistakable inference

the results were/are concealed. And he has also disclosed the existence of an autopsy report antedating the "official" autopsy report, which was discussed by the Commission in executive session, with the irrefutable conclusion the existence of this document has been concealed. Thus two more mysteries have been discovered and the task of laying bare the truth made, at once, simpler and more difficult. We'll have a guest of radiocasted Long John on WMCA on Thursday, Nov. 16 1974. Presumably he will talk about these finds which he has embodied in an article scheduled to be published in Modern Medicine, in December, I believe. I intend to listen to the program. If you live I'll write you about it!

Now, take a few minutes to explain what you mean by kidnapping rebuttal witnesses in the Bay hearing. Is that a worthier enterprise than kidnapping presidential corpses?
