Dear Gary and Paul,

It has been a long day again, and I have a new accumulation of materials requiring simultaneously immediate attention, so I'm writing you briefly to bring you up to date. This is for the two of you only, for the moment, please, quite literally. When I can I'll describe the new materials I have.

Bud readily, enthusiastically, agreed to separation of my suit into two suits, one to proceed immediately and one to be prepared with more care. The one on which we will proceed immediately is the DJ denial of the public court record on two openly spurious counts: they do not have what they presented in court in England to get ~~James~~ Ray extradited and if they did it would be an investigative file! Because Kleiniasat (as aptly named as "inck!") is rather transparent in his evasions, transposing and misrepresenting what I asked for, I today dictated a new letter to him in answer to the one I'll send when the machine is fixed (the repairman came again today and took part of it with him!) and we will await answer to that. Imagine the swine saying I asked for what was presented by the United Kingdom rather than the United States! Also, to eliminate any possible technicality, I also wrote a letter to the Secretary of State, who was the transmission belt. As soon as we get these answers, we'll file, separately, on that. This may mean more to Paul than to Gary: what I say in the COURT add about the evidence and its deliberate distortion is understated! For the moment I can say no more, but I can assure you, again with the emphasized injunction to complete silence, that I now have in my possession the irrefutable evidence. My analysis is in the finest detail precisely correct, on all the essential evidence, including eyewitness, ballistics and medical.

We has not yet had a chance to go over the last year of Archives correspondence so we have no final agreement on what we will sue for. We do have a general understanding, and we had no disagreements. Paul, he has no doubt at all about the notes and I now have in my possession what explains their absence. Again, I dare not now say more. The only area of disagreement is on the pictures and X-rays, and I do expect him to agree to this. However, he is uncertain. This was the last thing we went into and by the time we had to quit I believe he had pretty much come around to my way of thinking. My approach is not John's, my reason is not his and my evidence and witnesses will not be. Paul, getting that copy of 1075:301 was important, for it cannot, he agrees, be withheld under any guideline or regulation. If you read it carefully and remember what I have sent you in the past, you will better understand why it is withheld.

There now seems a good likelihood that we will be joined by a constitutional lawyer. I delayed until today getting in touch with the man turned off by a the purloined too-many-guys bit and he is again agreeable and he has again promised to introduce me to the Kennedy-men who he thinks may get interested. I should say former K-men. I am encouraged. So, for what my evaluation is worth to you, I seek to share this encouragement.

I have also obtained some of the missing papers from another agency, not the Archives. They are very important. Unfortunately, I can again say no more at the moment, but because I have kept you well briefed in the past if you think about this you should have little difficulty making an accurate guess.

I have written Mary for both of you for Curry books and have mailed the letter. Although Bud had read it and I had not, and although Mary says there is nothing new in it, my cursory examination shows there is potentially great value. As I go into this to duplicate what immediately interests me and send you copies you will understand this better. Sorry I cannot be more detailed. Best regards,

Bud can get what I will ask you for in due time, but he'll get a legal version which will be large. I need a small chart of the human skeleton with the bones identified. Do you have one or can you get me one through the hospital? It needn't be in the finest detail, but I'd like one sufficiently detailed to identify the different vertebrae, for example, and the major bones of the head (not skull alone, but the entire head, for I want it for both assassinations).

In haste and tightest, strictest confidence, I tell you I now have the best thing I have yet. Under the proper auspices and on the proper occasion, it may well do what everything else has failed to do.

When you get the COUP add from Paul and get into my analysis of the ministerial evidence, accept my assurances that my analysis is as close to perfect as is humanly possible, for I now have the irrefutable proof in my possession. I indicate the general ~~xxx~~ areas in the letter to both of you. And I think that in both cases I will have new allies, of the sort we have never had.

As soon as I can I'll be writing both of you again. I think I'll ask in advance that Paul agree to neither mention nor pursue the successful area. You know my fear in this direction, and I may decide against running the risk, for he has been too careless. You, however, will understand and I depend upon your complete silence on this. I believe I will want to use this first in court and take them by surprise.

Bud is satisfied that with reasonable luck we can blast the thing in court without my yet having told him this.
