Dear Mr. Weisberg,

I wanted to thank you for the information you gave me regarding my endeavor in the assassination of John F. Kennedy. I have centered by research on the police radio logs during the time of Tippit's murder.

I contacted Garry Mack in Texas the day after our conversation. He told me he is working on the theory of a fourth shot regarding the Kennedy assassination. I informed him of my interest in the Tippit slaying. We spoke of the time discrepencies in the logs, and the Warren Commission's account of Oswald's arrival to the scene. If Oswald did leave his house at a little after lpm and if he did indeed walk a block a minute, as the Commission contends, then he could not have gotton to the scene until 18 minutes after he left the rooming house. The logs say the murder took place at about 1:16pm, thus Oswald could not possibly have been there at that time.

We, Garry Mack and I discussed "the other witnesses", and I have investigated T.F. Bowley's testimony, and compared it with Benavides' testimony, as well as draw up a rough map of the area of 10th and Patton, Jefferson, Denver streets. Things are becomeing more and more curious to me.

In any event, Garry Mack gave me some leads to supplement my research. One of those leads are the articles in <u>Gallary</u> magazine written by Earl Golz of the Dallas Morning News. These articles appear in the November and December 1982 issues. They discuss the "new Witnesses" involved in the Tippit slaying. I called around the city, and no store carries back issues. So I called the Publishing company in New York, and they referred me to somewhere else, and they told me it would take eight weeks to receive those issues, and that they would be five dollars a piece. I told them my interest and they are willing to speed up the procedure for me. However, I think Mr Wrone has the articles, and will allow me to use them.

Garry Mack also gave me the names of persons who would have the tapes of the police radio logs. Garry has the tapes, but does not have anything to reproduce them for my use. My efforts to contact the others who have the tapes have so far been fruitless, as their numbers are all unlisted. Is there a reason for this? Do these people have reason to be frightened? Am I going to have to live in fear if I get hold of these and discover something devistating to the Warren Commission's procrustian thesis? I haven't had so much fun in a long time!

You asked me on the phone if I had the document which says that the FBI had the police radio tapes for reproducing a transcript. Well I enclosed what I had found, however, I think that the FBI was only allowed to use the tapes at the
