SYNOPSIS

Information re subjects Knapp and Lujan participants in line up 11-23-63 with Lee H. Oswald.

DETAILS OF INVESTIGATION

Reference is made to a letter undated from Mr. J. Lee Rankin, General Counsel, President's Commission on the Assassination of President Kennedy. This letter requests that the U. S. Secret Service provide the Commission with the ages of David Knapp and David Lujan, both of whom participated in a line up with Lee Harvey Oswald on November 23, 1963.

Other Investigations

On Aug. 3, 1964, I determined from the records of the Dallas Police Dept. the following information relative to Knapp and Lujan:

The subject referred to as David Lujan is listed incorrectly in Police records show this subject's actual name as Daniel Guitierrez Lujan. This subject was arrested by the Dallas Police Department on 11-21-63 and released by them on 11-23-63 at 4:50 PM. This man was photographed by the Dallas Police Dept. on 12-22-62 and this photo is attached. He is described as a white, male; (DOB: 2-15-37), 5-8 $\frac{1}{2}$; 163#; brown eyes; black hair; brown complexion. On 11-22-63 this man was 26 years old.

David Edward Knapp was arrested by the Dallas Police Dept. on 11-21-63 and released by them on 11-24-63 at 4:35 pm. The subject was not photographed and we have not been able to locate him to secure photos. His date of birth was 10-22-45 and was 18 years old on 11-22-63.
