## Oswald-Shaw Link Claimed

NEW ORLEANS — District Attorney Jim Garrison charged today that Lee Harvey Oswald plotted the assassination of Prrsident Kennedy with New Orleans civic leader Clay Shaw, 54, and former airline pilot David W. Ferrie in Rerrie's apartment in September of 1963.

Garrison made the allegations in an affidavit filed yesterday and made public today, to substantiate a search warrant for Shaw's apartment.

Injected also into the story was a truth serum angle.

Shaw, it was also revealed today, was in San Francisco the day Kennedy eas killed (See Page 9.)

## **REASON GIVEN**

Shaw ,a properous retired business executive ,was arrested last night by Garrison. Ferrie, found dead Feb. 22, was described by Garrison as a key figure in his probe of Kennedy's death.

A search warrant used to gain entrance to Shaw's French Quarter apartment last nigh stated this reason for the search:

"Affiant has evidence that meetings were held in the apartment of David W. Ferrie at 3300 Louisiana Avenue Parkway and the people present were David W. Ferrie, Clay Shaw, alias Clay Bertrand, and Lee Harvey Oswald and an informant and other persons.

"These meetings were held for discussing how they would kill John F. Kennedy, president of the United States."

## FBI PROBE

In Washington, the new U. S. attorney general, Ramsey Clark, said a FBI investigation in late 1963 had cleared Shaw of any part in the assassination. "On the evidence that the FBI has, there was no connection found," Clark said.

The search warrant used by Garrison's men said that

at the meetings between Oswald, Shaw and Ferrie, "there was an agreement and combination . . . to kill John F. Kennedy . . .

"One of the sources of information of the affiant is a confidential informant who was present at these meetings and saw the conspirators and heard . . . subjects discuss the means and manner of carrying out this agreement."

The warrant added that the informant voluntarily submitted to a lie test "adminis-

## STATEMENT

Shaw, who was released on \$10,000 bond last night, issued a statement today in which he expressed shock at this arrest and denied taking part in a plot to Kill Kennedy.

"I've always had only the highest and utmost respect and admiration for Mr. Kennedy . . . I do not know Harvey Lee Oswald nor to the best of my knowledge do I know anyone who knew him. I have never seen or spoken a to Oswald where anyone I knew was associated with chim."

In answer to a question about the name "Clay Bertrand," Shaw said: "I don't know of any Clay Bertrand

Clay Shaw, charged in New Orleans with conspiracy to assassinate President Kennedy, was in San Francisco on Nov. 22, 1963, the day of the assassination.

Shaw, then managing director of the new International Trade Mart in i New Orleans, made arrangements for a room at the St. Francis Hotel and a talk to San Francisco trade leaders through J. Monroe Sullivan, then executive director of the San Francisco World Trade Center.
