NINE ZERO EIGHT FOURTEENTH STREET, MANHATTEN BEACH, CALIF.,  
OF WHICH A COPY WAS DIRECTED TO CHIEF JUSTICE EARL WARREN.

THROUGHOUT THE LETTER MRS. LOCHNER PROPOUNDS NUMEROUS  
QUESTIONS AND MAKES VARIOUS STATEMENTS RE CAPTIONED MATTER,  
BUT DOES NOT OFFER ANY EVIDENCE IN CAPTIONED CASE.

LETTER BEING FORWARDED TO LOS ANGELES BY AIRMAIL.

LOS ANGELES WILL CONTACT MRS. LOCHNER AND INTERVIEW HER  
FOR ANY INFORMATION OF VALUE SHE MAY HAVE RE CAPTIONED  
MATTER.

THREE SEVEN VARNA AVENUE, NORTH HOLLYWOOD, CALIF, PHONE  
P O FOUR EIGHT FIVE FIVE SIX. IN THE LETTER MR. KURT  
EXPRESSES IN LENGTH HIS PERSONAL VIEWS RE CAPTIONED MATTER  
AND PROPOUNDS SEARCHING QUESTIONS, PRIMARILY HAVING TO DO  
WITH HIS INABILITY TO UNDERSTAND HOW THE PRESIDENT WAS HIT  
IN THE THROAT AFTER HE HAD FALLEN OVER, STATING THAT THE  
FIRST SHOT HIT THE PRESIDENT IN THE HEAD. IT IS NOTED THAT  
MR. KURTZ HAS THE SEQUENCE OF SHOTS IN REVERSE IN THAT THE  
FIRST ROUND STRUCK THE BACK AND THIRD SHOT HIT THE  
PRESIDENT-S HEAD. MR. KURTZ DOES NOT STATE HE HAS ANY  
SPECIFIC INFORMATION RE CAPTIONED MATTER, BUT HE SHOULD BE  
INTERVIEWED PROMPTLY FOR ANY INFORMATION HE CAN FURNISH RE  
THIS MATTER.
