ASSASSINATION OF PRES. KENNEDY, AFO.

INFORMATION HAS BEEN RECEIVED BY DALLAS OFFICE IN THREE SEPARATE TELEPHONE CALLS, ALL FROM ANONYMOUS FEMALE, INDICATING THAT CALLER THOUGHT FORREST SORRELS, DALLAS HEAD OF SECRET SERVICE, SHOULD BE INVESTIGATED. IN FIRST CALL, CALLER STATED SHE IS A MEMBER OF THE LOCAL THEATER GUILD AND ON NUMEROUS OCCASIONS HAS ATTENDED FUNCTIONS OR SPEECHES WHERE SORRELS HAD SPOKEN. SHE MAINTAINS SORRELS SHOULD BE REMOVED FROM HIS POSITION AS HE IS INCOMPETENT AND DID NOT HAVE THE ABILITY TO PROTECT THE PRESIDENT. SHE STATED HE WAS ANTI GOVERNMENT, AGAINST THE KENNEDY ADMINISTRATION AND SHE FELT HIS POSITION WAS AGAINST THE SECURITY OF NOT ONLY THE PRESIDENT, BUT THE U. S. SHE REFUSED TO FURNISH HER IDENTITY OR HER ADDRESS.

ADDITIONAL CALL RECEIVED FROM ANONYMOUS FEMALE, STATING

THAT SORRELS SHOULD NEVER HAVE BEEN PERMITTED TO HAVE THE RESPONSIBILITY FOR THE SAFETY OF THE PRESIDENT. THE CALLER COMMENTED THAT SORRELS WAS ANTI GOVERNMENT, FREQUENTLY MADE REMARKS THAT HE DID NOT BELIEVE IN ALL THE POLICIES OF THE GOVERNMENT AND HE SHOULD

BE INVESTIGATED.

THE THIRD ANONYMOUS CALL STATED THAT SORRELS SHOULD BE CHECKED ON. THE CALLER STATED SHE WAS A MEMBER AT ONE TIME OF THE LEAGUE FOR WOMEN VOTERS, AS WAS THE WIFE OF SORRELS. SHE CALIMED MRS. SORRELS, WHEN TAKING HER TURN TO MAKE A BOOK REVIEW, DID NOT MAKE A BOOK REVIEW AS MOST OF THE MEMBERS DID, BUT INSTEAD GAVE A REPORT ON OVERTHROWING THE GOVERNMENT. THE CALLER STATED ON THIS BASIS, SHE THOUGHT MR. SORRELS ACTIVITIES SHOULD BE CHECKED INTO.

THE LAST TWO CALLS WERE RECEIVED IN THE DALLAS OFFICE BY THE SAME AGENT AND THE AGENT IS OF THE OPINION THE SAME WOMAN WAS CALLING ON BOTH OCCASIONS. IN ALL THREE INSTANCES, THE CALLER APPEARED TO BE AN INTELLIGENT PERSON AND WAS WELL SPOKEN AT THE TIME SHE CALLED.

INFORMATION CONCERNING THE THREE ANONYMOUS TELEPHONE CALLS RELATIVE TO SORRELS HAS BEEN FURNISHED TO INSPECTOR TOM KELLEY, SECRET SERVICE OF WASH., WHO IS PRESENTLY IN DALLAS.
