Dear Counselor,

First of all, my best wishes for your health, happiness and success for the year 1982. I received your parcel (?) but not until the 26th of December, so I wasn't able to telegram as you requested. I'm back from Madrid and here is some of my investigation.

As I already have written you, SOUETRE officially resided in Spain from 1962 to 1971. He had two firms and shares in a third, that of Commander CONSTANT, whose identity he used. The first was domiciled Palma Nova de Majorque and was a business, the, domiciled at Madrid, was an extermination and fumigation company, "Will-Kill". This company hired most of the survivors of the Delta group. More particularly the Hungarian group, whose principal members were LASLO VARGA, MARTON and GUYLA SARI.

But SOUETRE was in reality outside of Spain and travelled a lot in Latin America (Argentina with General GARDY) and to the Caribbean. His "cover" in the Antilles-Trinidad was as a director of a bungalow construction company, then by a position as director, totally fictitious, of a sugar refinery in Martinique. This sugar refinery had its head office in France at ARCIS sur AUBE. Then afterwards he had a position, also fictitious, as director of a firm for industrial development in the Caribbean (S.D.D.I.C.) which is none other than a branch of the Groupement Francais d'entreprises (G.F.E.).

In March-April 1963 SOUETRE met HOWARD HUNT in Madrid, in the company of PEREZ, the director of O.R.O. There had been questions concerning the creation of, and above all, the formation of the International Anti-Communist Bridage, and on this occasion these Hungarians and BUSCIA (as well as MARTON and LAZLO VARGA) went in the direction of the Caribbean, then towards New Orleans. They rediscover someone called BRINGUIER, director of the Free Cuba Committee.

Then SOUETRE met--still around April-May 1963--with General Edwin A. Walker at Dallas. Always at the training program of Anti-Castro groups, Alpha 66 and the 30 November group. Arms were furnished by the intermediary at the GUANTANOMO naval base. Training took place at the New Orleans region of MANDEVILLE. Their Q-G ["Quartier General" or "Headquarters"] was 544 Camp Street.

I point out that extremely close ties have always existed between the anti-Castroites in Florida and the French extreme right through the intermediary of ex-O.A.S. members who emigrated to Argentina, Paraguay and to Venezuela.

As to pondering certain weighty questions:

1) CURUTCHET had been at the airport at Dakar, Senegal during a technical layover or stop of the airplane from a normal airline which carried him. In no way could he have been stopped in Rome and extradited.

2) The photos correspond to legionaires who deserted the 7th R.E.P. They have all belonged to the DELTA group and left Algeria for Spain at the end of 1962. Numbers 1 and 2 are of Hungarian origin. Their identification is on the way.

3) The first name of the ship's lieutenant, Mr. Roy, is indeed Jacques.

I am sending you another letter in about ten days before I see Souetre's former buddies.
