III. REASONS FOR OFFICIAL RESISTANCE:

- A. SPECTRO - SHOWS OPPOSITE OF OFFICIAL JFK STORY; SHOWS FBI FAKING, SUPPRESSING OF THE ESSENTIAL EVIDENCE
- B. KING THE SAME, EXACT PARALLEL IN IDENTICAL EVIDENCE. SPECTRO/NAA, SCENE CRIME PIX, ETC.
- C. EX SESS TRANSCRIPT - FORD AS MCCARTHY, OSWALD AS AGENT, WHAT DEFECTORS SAID, EXPOSURE OF CIA, FBI

IV. WHAT GOVERNMENT IS DOING TO NULLIFY ACT, SEEK AMENDMENT;

A. WASTE TIME TO BUILD PHONY STATISTICS AND INFLATE COSTS

1. SEARCH WRONG, DO NOT SEARCH RIGHT FILES. ILLUSTRATE JFK AND KING ON SPECTROS
2. NO FIELD OFFICE SEARCHES IN KING, MOST FILES THERE
3. MASKINGS AND WITHHOLDINGS WITHOUT NEED OR SANCTION - MORE THAN 50% WITHHOLDING REVERSED ON INTERNAL REVIEW, MORE IN OVER

~~B. CONTRIVE DELAYS IN COURT BY LATE FILINGS,  
IRRELEVANCIES, DISTRACTIONS AND DIVERSIONS~~

1. LATE FILINGS MEAN ANOTHER STATUS CALL  
FOR RESPONSES BY PLAINTIFF AND GIVE  
GOVERNMENT MORE DELAYS IN EXPOSURE AND  
USE OF EXPOSURE

2. NAME OF GAME IS STALL

C. FBI, DJ, CIA GUARANTEED LOGJAM BY PRETENDING  
NO REASON TO BELIEVE PEOPLE WOULD USE ACTS  
AND THEN DELAYING ANY REAL STAFFING UNTIL  
MORE

THERE WAS A REAL BACKLOG. USE KING AS ILLUSTRATION - 88 VOLUMES, 2 A WEEK, ETC. STILL INADEQUATE STAFFING.

- D. OVERLOADS COURTS THEN OVERLOADS FURTHER BY UNNECESSARY WORK, LIKE HAVING TO GO OVER THOUSANDS OF RECORDS, MAKE INVENTORIES, ETC
- E. GO TO CONGRESS FOR "RELIEF" - ACTUALLY, RESTRAINTS ON WHAT PEOPLE CAN KNOW AND OBTAIN. SHEA - INSTEAD OF BEING IN COURT TO BE QUESTIONED BY US.
