

THE WARREN COMMISSION BEHIND THE SCENES - THEIR

THIS DISTINGUISHES BETWEEN THE COMMISSION'S OWN
SECRETS AND THOSE IT OBTAINED FROM EXECUTIVE
AGENCIES, OR "SUPPRESSED EVIDENCE." SOME
OVERLAP.

MOST OF COMMISSION'S OWN SECRETS IN ITS STAFF
PAPERS AND EXECUTIVE SESSIONS.

MOST OF ITS OTHER SECRETS FROM FBI; CIA. SOME
EVIDENCE REMAINED SECRET BECAUSE IT WAS NOT
WANTED. MEDICAL, SCIENTIFIC TESTS EXAMPLES.

OVER

THE COMMISSION ORIGINALLY PLANNED A MAGAZINE-TYPE
REPORT AND NO EXHIBIT VOLUMES. PRESSURE FROM
WHITE HOUSE FORCED PUBLICATION OF 26 VOLUMES.
AFTER COMMISSION'S LIFE ENDED ITS FILES TRANS-
FERRED TO ARCHIVED. IT HAD A PART-TIME 2-MAN
STAFF TO ARRANGE RELEASE. VERY SLOW. ~~NUMBERS~~
NUMBERED RECORDS FIRST, THEN STAFF PAPERS,
ALL INITIALLY WITHHELD.

WARREN AND RFK WANTED ALL POSSIBLE RELEASED.
SOME EXECUTIVE SESSIONS NOT YET RELEASED.
I'M SUING TO GET THEM NOW. STAFF PAPERS

STILL STALLING ON 6/23 TRANSCRIPT. TELL STORY OF.
READ DRAFT OF REPORT AND SELF-PRAISE FOR COMPLETE
HONESTY AND NOTE NO MENTION OF NOSENKO IN IT.
SPOOKS WANTED AND COMMISSION NEEDED THIS KIND OF
SECRECY. OTHERWISE @OULD NOT EXPECT THE
CREDITING OF ITS PREDETERMINED CONCLUSIONS.
