Speculators Forcing Food Prices Up for Personal Gain

During 1973 the grocery-store price of food rose 23.1 per cent. This year, according to Agriculture Department calculations, it probably won't rise more than another 17 per cent. Many economists call that estimate "overly optimistic," however, and say that food prices will rise at least as much in 1974 as they did in 1973.

Standard of Living Down

Considering the sharply rising cost of housing, transportation, and utilities, as well as food, the actual cost of living for most middle-income Americans is

climbing at a rate of nearly 20 per cent a year! Despite substantial wage increases, the standard of living of the average American worker is being inexorably forced down year after year by this soaring cost of living.

Hardest hit are those Americans living on fixed incomes. Retired persons barely able to make ends meet a year ago are now faced with the bitter choice of either applying for government welfare or starving. Even those who have cost-of-living adjustments in their pensions have been forced to the edge of desperation, because the adjustment is always less than the actual increase in living costs.

Number on Welfare Up

The vastly increased number of persons on welfare—including many White persons who have never before had to accept handouts—is reflected in the \$11 billion slice (37 per cent) of next year's Federal budget reserved for welfare payments. This, of course, increases the already staggering tax burden on working Americans.

The questions Americans are asking are: Why must it be like this? Why can't we have a stable economy? Who is responsible for this mess?

Bad Government

Not all the answers are simple, but neither are they as complex and obscure as the doubletalk coming from Washington suggests. In the first place, the cause of the overall inflation is weak leadership—in other words, bad government.

American society, like others, consists of a great variety of

different groups, each with its own particular interests: labor unions, farmers, manufacturers, merchandisers, truckers, importers and exporters, oil producers, mine owners, land developers, bankers, packinghouse owners, and many others. Each group strives to maximize the income of its own members, subject only to the restraints of social responsibility and government.

Need for Responsibility

With a strong and responsible government—and a strong sense

of social responsibility on the part of the various components of society—a more-or-less dynamic but generally stable and equitable compromise between all the special interests can be achieved and maintained. Because of the dynamic nature of the balance, individual prices may fluctuate within reasonable limits, but the overall cost of living can be kept constant year after year. As technological advances allow increased productivity and worker efficiency, the standard of living can steadily increase without inflation. That's the way the

American economy should—and could—work.

No Togetherness

But it doesn't. In the first place the government in Washington has lost its sense of responsibility, and it is also rapidly losing its grip. Partly as a consequence of this and partly as a consequence of the lack of racial homogeneity required for a genuine sense of national "togetherness," America's various special-interest groups are displaying a shockingly small

Political Police Used Against White Groups

FBI Growing Threat to Freedom

Recent press stories dealing with the Federal Bureau of Investigation have created the false public impression that three years ago the FBI abandoned the quasi-legal and illegal harassment tactics it formerly employed against dissident political groups.

Reaction to Criticism

Having raised the specter of an out-of-control political-police agency, Nader and the press then largely dispelled that specter. One of the FBI memos which they obtained and published was an edict from Hoover dated April 28, 1971, ordering the immediate termination of all COINTELPROs.

communist, and pro-German groups which posed a threat to Roosevelt's efforts to develop a pro-war sentiment among the American people so that he could bring the country into the war then raging in Europe. Throughout 1940 and 1941 Hoover's agents harassed the isolationists, broke up their meetings, arrested them on spurious charges, opened their mail, burgled their homes and offices to steal documents which could be used to blackmail them, and otherwise made their lives miserable and prevented them from effectively informing the American people of the conspiracy to use young Americans as cannon fodder to save the Soviet Union and to help the Jews wreak their revenge on Germany.

Media Collaboration

The FBI even turned over raw data from their files on isolationists to such media smear-artists as Drew Pearson and Walter Winchell, who then obligingly used the data to attack the unfortunate victims in their newspaper and radio columns. With very few exceptions they found no champions in the media, no one who would raise a public outcry against these police-state tactics. The media were already overwhelmingly in the hands of men who noticed repression only when it was directed against the Left.

After World War II, however, with Roosevelt dead and a growing public disenchantment with our former "gallant Soviet ally," Hoover was allowed to return briefly to his first love: using the Bureau against the communists. He dragged into the open the Rosenbergs and hundreds of other Red agents who had been allowed to carry on their destructive work unmolested during the war years. In this, there can be no doubt that

Secret Documents Revealed

There was much clucking of tongues by media liberals when the FBI first revealed what had long been general knowledge but never before openly admitted, namely, the Bureau's policy of harassment of political groups. The revelation came last December when, in response to a lawsuit by Ralph Nader, a Federal judge in Washington ordered the FBI to cough up internal memoranda dealing with its so-called "counterintelligence programs" or, in FBI jargon, "COINTELPROs."

The COINTELPRO memoranda described a program of surveillance, intimidation, illegal arrests—even burglary—designed to disrupt and hamstring dissident political organizations of all complexions. In the words of the late director of the FBI, J. Edgar Hoover:

"The purpose of this program is to expose, disrupt, and otherwise neutralize the activities of the various (dissident) organizations, their leadership and adherents. It is imperative that the activities of these groups be followed on a continuous basis so we may take advantage of all opportunities for counterintelligence...We must frustrate every effort of these

Since 1940

Unfortunately, this is by no means a new situation. It has been with us for 35 years.

From the time the FBI came into existence in 1938, it was engaged in a no-holds-barred fight with communist organizations in America. That lasted only until President Roosevelt ordered Hoover to lay off the Reds, however, shortly before the United States entered World War II.

But Roosevelt gave Hoover a new target in 1940: the various isolationist, anti-Jewish, anti-

he performed a vital service to the nation.

the heat off the communists and directing it elsewhere.

Against All Boat-Rockers

But the mind of the political policeman is strange. He is not ideologically oriented, in general. He does not distinguish good "radicals" from bad ones: Anyone who is opposed to the System which pays the policeman's salary is an enemy. All those who are boat-rockers, all who are non-conformists, are regarded with suspicion.

He would as soon lock them all up as look at them. The only reason he doesn't is that he has learned that some of them can bite. Those are the ones who have the sympathy of the news media. So with doubled zeal he goes after the ones who can't bite.

Treason, Yes: Anti-Zionism, No

And that, unfortunately, is about where it stands today. Ramsey Clark, Jane Fonda, and other traitors and degenerates can with impunity break Federal laws by consorting with the enemy in time of war. Daniel Ellsberg and his friends can steal top-secret military documents and publish them. Black revolutionaries can kidnap the daughter of a White multimillionaire and hold her captive for months, while the FBI twiddles its thumbs. But just like a patriot publicly criticize Washington's pro-Zionist policy in the Middle East, and the FBI will be noting into his private affairs in a trice.

Media Masters Protect Reds, Blacks

Hoover knew that the late Negro leader, Martin Luther King, Jr., was a front man for the Reds. He knew that King had attended communist training schools and received financing from the Southern Conference Educational Fund, the Southern arm of the Communist Party U.S.A.

He also had plenty of dirt on King's private life. He had films of King having sexual intercourse with white prostitutes in various motels during his "freedom marches."

But King was the darling of the media liberals, and Hoover knew they would scream bloody murder if he laid a finger on him. So he took out his frustration on the White opponents of school integration instead.

Actually, the FBI became increasingly restricted in its anti-Red activities since the late 1950's. After the so-called "McCarthy era," when the Bureau put a real crimp in the Red apparatus in America and scared the neo-liberal Establishment out of its wits, the media became more and more critical of Hoover and the FBI. Hoover, always sensitive to political pressure, gradually began taking

FBI Is Necessary

It may be regrettable, but it is a fact of life that political police are an indispensable prop for all modern governments, whether they are "totalitarian" or "democratic." The only difference is that the totalitarians are less hypocritical in acknowledging this fact.

Urban, industrial societies are such complex and finely tuned mechanisms that it is relatively easy for any determined and moderately well-disciplined group to throw a monkey wrench into their gears. Without a national, political police force to counter such groups, they can do an enormous amount of damage and will eventually pull down any government. Local police departments simply cannot cope with them.

The problem in America today is not so much that the country has become a de facto police state. Rather, it is that the wrong people are in charge of the police. The consequence is that patriots are harassed, and the real enemies of the nation are allowed to run at large.

How to Cope

The time will come when this situation will be reversed, but for now it is a cross which must be See POLITICAL POLICE, p. 3

INTERNAL SECURITY
DISRUPTION OF HATE GROUPS

The Bureau is pleased with past successes achieved by our counterintelligence efforts in other phases of our investigative responsibilities. To insure our success in this new endeavor, the Agent to whom the program is assigned in each office must have a detailed knowledge of the activities of the racist groups in the territory and that knowledge must be coupled with interest, initiative and imagination. The Agent must be alert for information which has a disruptive potential. This information will not come to him -- he must look for it. The most effective way of being assured of success on top of the situation is to maintain close contact with these Agents who handle the investigation of the racial and hate groups and their membership and also to periodically review relevant files.

If an enthusiastic approach is made to this new endeavor, there is no reason why the results achieved under this program will not equal or surpass our achievements in similar type programs directed against subversives.

PORTION OF RECENTLY DISCLOSED HOOVER LETTER of September 2, 1964, ordering harassment of racially oriented organizations. Note emphasis on spying for "information which has a disruptive potential." This surveillance and harassment of law-abiding citizens by an agency of the Federal government is typical, even though most taxpayers remain unaware that their taxes are financing such police-state activities.

Solzhenitsyn and the Liberals

When Alexander Solzhenitsyn, the Russian dissident writer who was exiled by the Soviet government in February, recently shouted at a group of Western newsmen, "You are worse than the KGB (Soviet secret police, equivalent to our FBI)," they were understandably hurt. After all, had not the newsmen of the democratic West made a great folk-hero of Solzhenitsyn, praising him to the skies at every opportunity? Had they not publicized his books for years, leading to their widespread sales outside the Soviet Union — and to a Nobel Prize for Literature for him in 1970?

Krushchev Goofted Too

Alas, the neo-liberal media masters of the West were finding to their sorrow that they had misjudged their man as badly as the communist masters of the Kremlin had earlier. Solzhenitsyn's world renown as a writer began in 1962, when Nikita Krushchev sponsored the Soviet publication of *One Day in the Life of Ivan Denisovich*, an autobiographical novel of Solzhenitsyn's experiences as a prisoner in Stalin's death camps. Krushchev was promoting the de-Stalinization of the Soviet Union, and Solzhenitsyn's criticism of Stalinism fitted the party line perfectly at that time.

Later, however, the Soviet leaders began to realize that Solzhenitsyn was opposed to a great deal more than just Stalin's particular brand of communism. They tried to shut him up, but it was too late; they had already given him a reputation and an

international audience, and Solzhenitsyn continued cranking out new books which blasted away at the very foundations of the Marxist-Leninist worldview.

Not a Jew

The shallow-minded liberals of the West seized on these books as props for their libertarian-democratic philosophy, as opposed to Kremlin authoritarianism. They mistakenly assumed that any Soviet dissident is automatically a neo-liberal — as, indeed, a whole platoon of dissident Jewish-intellectual contemporaries of Solzhenitsyn's are.

But Solzhenitsyn is a genuine Russian, not a Jew. His worldview comes from deep in his Russian soul, and it is as hostile to neo-liberalism as it is to Stalinism.

That fact was made manifest last month when Solzhenitsyn released a long letter he had written to the Kremlin bosses. He urged them, for the good of Russia, to turn away from the "dark, un-Russian whirlwind of Marxism," as well as from the decadence of Western liberalism. (Marx, as also nearly all the other founders of communism, was both un-Russian and un-Western; he was a Jew.)

A Warning to Brezhnev

He condemned the murderous regime which had sent uncounted millions of his countrymen to their deaths, and he called for rooting out and punishing Stalin's fellow murderers who still hold positions in the Kremlin hierarchy. But more than that he warned Brezhnev & Co. not to let Russia fall victim to the democratic disease now ravaging the West.

How disillusioned Solzhenitsyn's admirers in the media must have been to read of his disgust at the "democracy run riot" in America — and, in particular, his citing of America's inability to cope with such termites in her timbers as Daniel Ellsberg and Ramsey Clark, both media idols! He also cited America's political parties and labor unions, her hypocritical neo-liberal intellectuals and corrupt officials, all engaged in a squalid "conflict of interests, just interests, nothing higher."

Liberalism Morbid, Inconsistent

But his denunciation of Western liberalism contained analysis as well as invective. He looked at the core of the malignancy and saw that it had no ethical foundation. It could neither provide a basis for sustained resistance to tyranny nor could it long support any civilization.

It had no coherent metaphysical structure; it was a morbid and unnatural condition of society, a pollution in the stream of history. It was as irrational and inconsistent as it was weak.

Maggots in an Apple

Solzhenitsyn had only scorn for the Western liberal's belief in

indefinite "progress" through industrialization: in a "growth" economy year after year, without limit. To him it was plain "that a dozen maggots can't go on and on gnawing the same apple forever; that if the earth is a finite object, then its expanses and resources are finite also, and the endless, infinite progress dinned into our heads by the dreamers of the Enlightenment cannot be accomplished on it. ... Economic growth is not only unnecessary but ruinous."

He dreamed instead of a stable economy, of a limited population living close to the land and in harmony with Nature.

Horror of horrors, he even suggested striving for racially homogeneous communities by dividing the Soviet Union into several separate ethnic regions. That way White Russians and Oriental Kalmucks, for example, could preserve their own racial identities and pursue their own destinies.

To Become an Unperson

The first reaction of media liberals to Solzhenitsyn's letter and his comparison of them to the KGB was embarrassment and a few nervous giggles. As it dawned on them that he really meant what he said, they moved to undermine the public prestige their former praise had given him. *Newsweek* (owned by the Washington Post) called him a "holy fool" and referred to his views as "idiosyncratic in the extreme."

Their next step will be to relegate him to the status of an "unperson" and cease to mention his name at all.

Liberation Is Un-Western

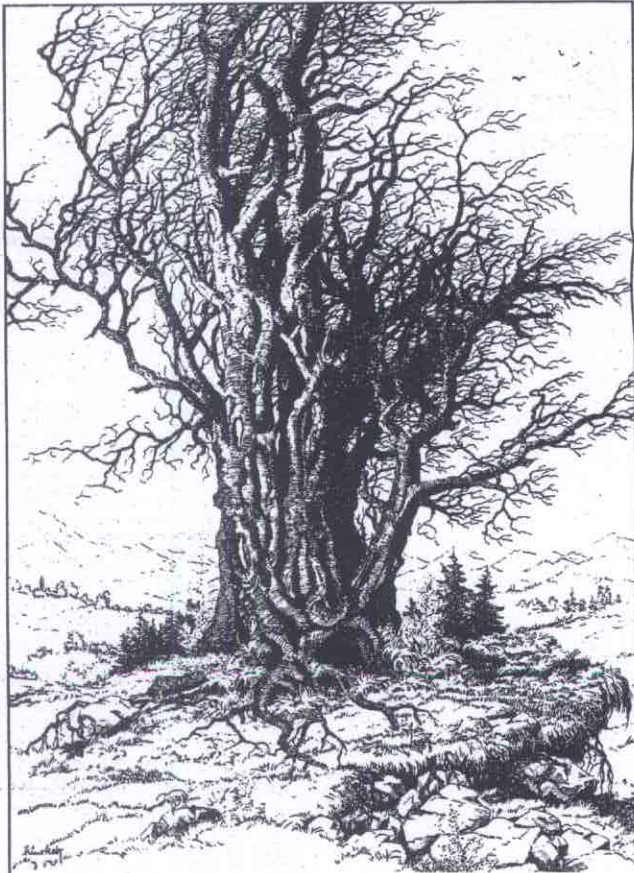
If ordinary Americans can find anything at all to criticize in Solzhenitsyn's views, it is his insistent reference to Western decadence, Western indiscipline, Western liberalism. Doesn't he

realize that liberalism (or, more correctly, the neo-liberalism which passes for traditional liberalism today) is as un-Western as Marxism is un-Russian, and for the same reason?

If neo-liberalism were a true expression of the Western soul, then there would indeed be no hope for the future. We could look forward only to increasing moral decadence and social chaos, accompanied by a more-or-less-gradual racial mongrelization, until, having altogether lost the capacity for sustaining any semblance of civilization or even maintaining a national defense, we became a serf-nation under the heel of any better-disciplined race who found it worth their trouble to enslave us.

Allen Apostles of Decadence

National Office Pushing Street Sales

One of the most important activities in which the members of our movement can engage is selling ATTACK! on the streets—regularly. For one thing, this

distribution of our publications; that dependence leaves us too vulnerable to future interference.

It has already been demonstrated in several areas of the country that a person can easily sell 200 copies of ATTACK! each week if he spends an average of four hours a day, six days a week, at it. At a profit of 20 cents on each paper, that is a dependable \$40 a week in pocket money for a diligent salesman. Even those whose work schedules limit them to weekend street sales can sell between 50 and 100 ATTACK!s in a weekend.

In order to help hesitant members get started on this important program, the National Office urges anyone who can spend a week—or even a couple of days—in Washington to do so. An experienced salesman will take each person out on the street and work with him until he has gained self-confidence and learned to sell effectively on his own.

Iowa NYA Member Hits Every House

Just a year ago Russell was being harassed by local officials in Villisca, who told him he couldn't sell ATTACK! on the streets without a license. He got a lawyer and made the officials back down.

White Prisoners Read ATTACK!

When a visitor brought a copy of ATTACK! to Edward Sullivan several months ago, he decided he wanted to read it regularly. But Mr. Sullivan is an inmate in the Men's Correctional Facility at Walkkill, New York, and the prison officials wouldn't permit him to receive issues of ATTACK! in the mail.

Noting that Negro prisoners were allowed to receive Black Panther and Black Muslim publications, Mr. Sullivan appealed the decision against ATTACK! and eventually was granted permission to receive it. When he finishes reading each issue he passes it on to other prisoners.

Last month he wrote the National Office: "Read your paper and thought it was good reading once again. I would like you to know that your paper is picking up quite a following in here. There are 41 readers on the list. I get a good response from the men here. Some tell me that after they are released from here they will get in touch with your organization."

The Symbol of Our Movement

At the top left of the front page of this ATTACK! appears the new symbol of the National Alliance/NYA and of the movement of liberation and national regeneration spearheaded by the National Alliance.

Several important considerations went into the choice of this particular symbol. First, we wanted a symbol as simple in form as possible, a symbol which could be instantly chalked or spray-painted on a fence or the side of a building.

Second, we wanted a symbol which would distinguish us from all other organizations, including any which might share some of our goals; a symbol which would be instantly recognized as ours, and ours alone.

Third, we wanted a symbol with a message, with ideological content, with an inherent meaning.

It would have been nice to also have a meaning which was already understood by most people, but that would have been asking too much. It will be our job to make the meaning of our symbol known. That, at least, has the advantage that we will not

have to begin by erasing any false notions in the public mind as to its meaning.

A few will already recognize our new symbol as a very old one: it is the so-called "man-rune" from the ancient alphabet, or futhark, used many centuries ago by our ancestors in Europe, from northern Italy to Scandinavia and from Iceland to Russia.

An interesting thing about the ancient runes is that each not only represents a sound, just like the letters of the Roman alphabet, but also one or more ideas. Thus, Y signifies creation, birth, and rebirth. It is the Rune of Life. The significance which we attach to it as the symbol of our movement is particularly that of rebirth.

Purely by coincidence the exponents of American surrender and decadence have chosen as their symbol one which is related to ours. Theirs, A, the so-called "peace symbol," is also a rune—in fact, the next in the runic alphabet after Y. It is the rune of negation, the Death Rune—and, as such, it is an appropriate symbol for our opponents in the struggle for the future of our people.

Pierce Suit Against Schlesinger Appealed

On February 15 the U.S. District Court in Alexandria, Virginia, ruled against ATTACK! editor Dr. William Pierce in his taxpayer's suit against Secretary of Defense Schlesinger. The suit was filed last October 26 as a consequence of Schlesinger's illegal transfer of U.S. war material to Israel.

Now Dr. Pierce's co-plaintiff in

the suit, Mr. Richard Cotten, has filed a notice of appeal with the U.S. Court of Appeals. It is hoped that the higher court will be less subject to Zionist political pressure and will issue the requested order for Schlesinger to take steps to recover all U.S. military items transferred to the Israeli government without proper statutory authority.

not endemic. It is unnatural, alien.

The slack-jawed philosophy of Benjamin Spock ("If it feels good, do it"), which has been impressed upon a whole generation of Americans through ultra-permissive child-raising practices, is not Western in origin.

The hyper-individualism which urges each person to find his own "sexual preference" (i.e., homosexual, bisexual, or "straight") without regard to social consequences, has no roots in Western tradition.

The ruling insanity of the racial-equality theorists, who steadfastly refuse to accept the plain evidence of everyday experience when it contradicts their babbling about universal human equality, flies directly in the face of a deep-grained Western objectivity.

We did not inherit from the American pioneers the feminine squeamishness which lies behind

our present inability to make the hard decisions and implement the stern policies needed to bring a final solution to a myriad of economic, social, and racial problems. Nor did that soft-mindedness, that weakness of will, striving only to postpone difficult decisions until they must become stern indeed, come to us from our European forebears who built the mighty edifice of Western civilization.

Because the disease of the West is a parasitic growth which has fastened itself onto the West's soul, and not an outgrowth of that soul itself, we can hope to cut it out and thereby cure ourselves, albeit with a great deal of pain and loss of blood — and greater the longer the surgery is delayed. We would feel an even greater admiration and sympathy for Solzhenitsyn if he had said that, instead of dismissing the West as being already in a terminal state.

For that matter, he did recognize the blood relationship

between neo-liberalism and communism in pointing out that it was a "liberal" movement in Russia, culminating in an eight-month period of "people's democracy" in 1917, which eroded the foundations of the old order and so prepared the ground for the ascendancy of Marxism.

The course of the disease in the West has been different than in Russia. Here liberalism has quite thoroughly obliterated all the old values, but then, instead of leading us promptly into communism, has lingered on and on.

Unfortunately, the West has probably suffered greater spiritual damage from its long cohabitation with communism's pimpling little sister than Russia has suffered from a half-century of communism itself.

Indeed, Solzhenitsyn may have had just that deep meaning in mind when he shouted to the Western newsmen, "You are worse than the KGB!"

We recognize that any truly progressive society cannot be based on an artificially imposed "equality", just as it cannot be based on a system of privilege according to wealth or social class, but must instead be organized so as to offer to each member of society an opportunity, commensurate with his demonstrated character and ability, for the contribution of the fruits of his talent to the whole community.

Third, an absolute rejection of neo-liberalism in all its sickly and destructive manifestations. We understand that this disease of the spirit, whether it raises its head in the guise of revolutionary Marxism or as the media-peddled philosophy-religion of the present System, is alien to our people and must be utterly rooted out and eliminated, along with its bearers.

Fourth, an eager willingness to take an active part in promoting our ideals and combating the enemies of those ideals, even when considerable self-sacrifice may be involved. That is, we all place the common interest before our self-interest and dedicate ourselves to personal struggle in behalf of that common interest.

What We Want

Our members are working to build a revolutionary new order of things in American life — a new order based on natural laws.

We want to develop in America a healthy cultural and racial approach to politics reflecting an understanding of authority, discipline, duty, and honor.

We want to achieve an organic society which will not only protect and perpetuate the great, traditional values of Western civilization but will purify the Western world of the degeneracy of communism and liberalism.

We want to secure for our people control over our own destiny by eliminating from the nerve centers of our society every anti-American and anti-Western influence.

We want to safeguard our racial identity by putting an end to the present insanity of enforced racial integration, which is threatening all involved with social chaos, cultural dissolution, and racial death.

We want to foster among our people, through the recapture of our information media and our educational system, a new spiritual outlook: the outlook of free men living and working in harmony with Nature.

We want to make possible for our people a new way of life, a meaningful and satisfying way of life as opposed to the present rat race in which every man and every woman exists simply as an exploitable economic unit.

We want our country, one day, to have a sane policy toward the other nations of the world, in place of the self-destructive idiocy which presently passes for American foreign policy. We need a policy based on a recognition that our interests are bound up with those of the other peoples sharing our common racial-cultural heritage, whether in Canada, Europe, southern Africa, Australia, or elsewhere, and that other races must develop in accord with their own, distinct racial-cultural imperatives — without help or hindrance from us except where such development poses a distinct threat to our own security.

Action Program

We realize that our long-range goals, because of their revolutionary nature, can only be achieved after political power has been wrested from the present System. Our activities at this time, therefore, are directed towards increasing our strength and effectiveness and generating public awareness of the alternative for which we stand by exposing the weakness, corruption, and destructive nature of the System.

Some of the specific aspects of our fight against the System are:

- Opposition to communism and neo-liberalism — in our schools, in the government, and in the streets.
- Opposition to Zionism — particularly the efforts of this alien conspiracy to entangle America further in the Middle Eastern conflict.
- Opposition to drugs and other forms of cultural and moral degeneracy.
- Opposition to all race-defiling efforts of the System, whether through school integration, forced housing, artificial job quotas, or other means.

IRS Moves to Censor NYA, Leaves

The Internal Revenue Service is engaged in a determined effort to revoke the tax-exempt status of the National Youth Alliance as a charitable and educational organization. This action is intended to deprive NYA of the reduced bulk-mailing rate it now enjoys and at the same time prohibit its supporters from deducting their contributions to NYA from their taxable incomes.

NYA will file a suit in the U.S. District Court in Washington this month in an attempt to halt the IRS harassment, but meanwhile the National Office is being bombarded with demands, interrogatories, and ultimatums from the Baltimore office of the IRS.

The ADL Connection

It all began last December, when syndicated smear-columnist Jack Anderson, successor to his former employer, the late and unlamented Drew Pearson, began "investigating"

NYA's tax exemption. Assisting Anderson was Peter C. Reynolds, who has described himself as an investigative agent for the Institute for American Democracy, a Washington front for the Anti-Defamation League of B'nai B'rith.

The principal activity of the Anti-Defamation League (ADL) is compiling dossiers on American citizens considered unsympathetic to Jewish commercial and political ambitions. The ADL has long maintained close ties with Anderson and, formerly, Pearson. Many Pearson-Anderson smear-columns have been based on ADL-supplied information.

Interestingly enough, Peter C. Reynolds is also employed by the so-called "Liberty Lobby," a Washington fund-raising operation which specializes in accumulating the names and addresses of Americans who contribute to patriotic or "conservative" causes. There are also

other links between the ADL and "Liberty Lobby."

Immediate Effect

On December 26, 1973, an Anderson column was devoted to a vicious smear of NYA and Dr. William Pierce, the editor of **ATTACK!** The gravamen of the column, which was carried by about 600 daily newspapers, was Anderson's assertion that NYA is a "hate" group and that it is scandalous that such an organization should be tax-exempt.

Three days later Anderson repeated and enlarged his complaint about NYA's tax exemption on network radio and television. He suggested there would soon be a congressional investigation of the matter.

The effect of the Anderson smear was immediate and dramatic. On December 27 the first two letters from the IRS arrived at NYA's National Office.

In the next few weeks these were followed by another six—all sent via registered mail and demanding one response or another from NYA, while threatening termination of NYA's tax-exemption.

Outside Political Pressure

NYA leaders meanwhile learned that Jack Anderson was not the only one who had been prompted to light a fire under the IRS. At least two neo-liberal Congressmen—Hugh Carey, of Brooklyn, and Joshua Eilberg, of Philadelphia—wrote letters to the IRS demanding action against NYA.

One of the IRS letters received in February is photographically reproduced below. Because it gives an insight into the mentality of the IRS bureaucracy which wields such an unwholesome power over the lives of all Americans today, it is worth reading in full.

The IRS letter nowhere alleges that NYA's original application for tax-exempt status was fraudulent, misleading, or otherwise invalid. Instead, it creates the impression that someone in the IRS bureaucracy was simply asleep at the switch when NYA's application was being routinely processed.

Now that everyone has been rudely awakened to the fact that a heterodox organization slipped past the IRS Inquisitors, the error is being corrected. That's all. No hint of outside pressure is given.

To Build a New Order

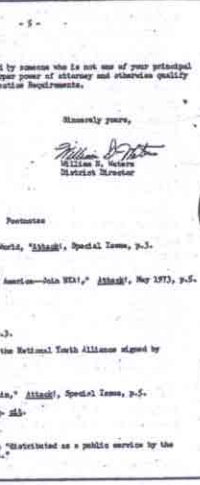
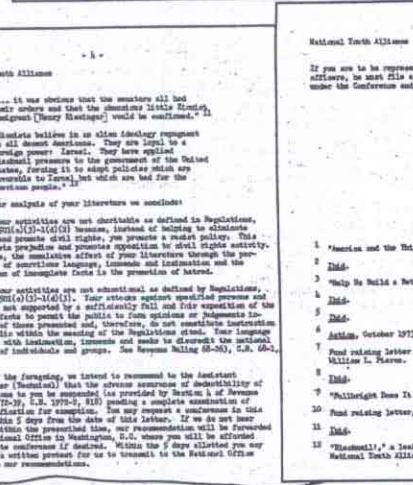
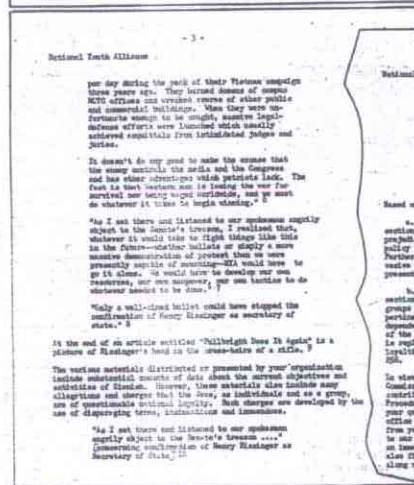
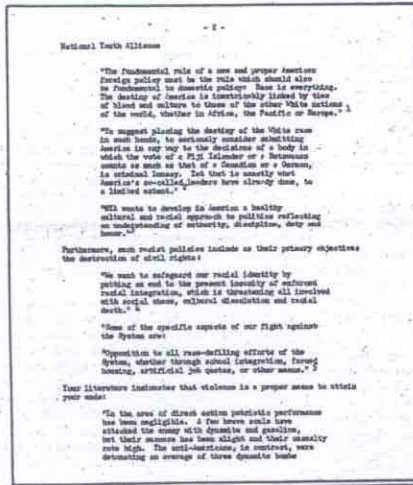
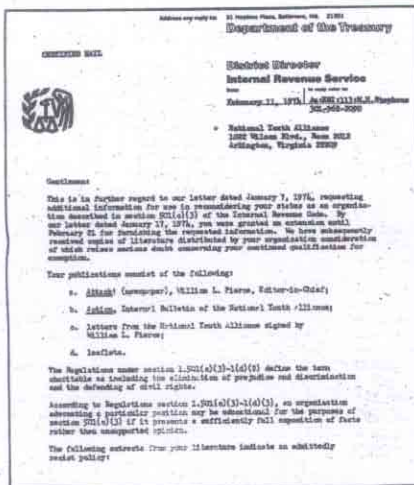
Actually, half of that impression is probably correct. Although the IRS required no NYA publications to be submitted with the exemption application, it did receive a copy of NYA's articles of incorporation. Those articles plainly state:

"The purposes for which the corporation (NYA) is organized are to establish lines of communication with university students and other young Americans; to develop in those with whom communication is established an understanding of and a pride in their racial and cultural heritage and an awareness of the present dangers to that heritage; and to unify those with such understanding, pride, and awareness into an effective force for building a new order in American life."

Heresy

That should have been enough to tip off any alert and right-thinking disciple of the TV religion that heresy was afoot. The guardians of equality, democracy, and the other sacred dogmas of the corrupt System which rules America were indeed asleep at the switch when they failed to notice that NYA did not bow down before the altar of neo-liberalism in its application and, in fact, didn't even claim to be an equal-opportunity employer!

The IRS has refused to acknowledge the outside political pressure which prompted their

effort to revoke the tax exemption previously granted. Although repeated requests have been made to them for copies of all letters dealing with NYA's exemption which they have received from members of the Congress or government officials outside the Internal Revenue Service, they have consistently ignored these requests. They have refused to confirm or deny the receipt of any such letters, even when confronted with press statements from the offices of Congressmen Carey and Eilberg acknowledging their interference in the case.

"Routine Review"

Instead, the pretense has been maintained that the action against NYA is strictly the result of a routine administrative review of NYA's status, originating within the IRS and not in the news media or the Congress.

On February 14 Dr. Pierce replied to the IRS letter of February 11. He sharply questioned the District Director's restrictive definition of the term "charitable," which limited it to "the elimination of prejudice and discrimination and the defending of civil rights."

Actually, the IRS Code states that charitable activities include: "relief of the poor and distressed or of the underprivileged; advancement of religion; advancement of education or science; erection or maintenance of public buildings or works; lessening of the burdens of government; and promotion of social welfare by organizations designed to accomplish any of the above purposes, or (i) to lessen neighborhood tensions; (ii) to eliminate prejudice and discrimination; (iii) to defend human and civil rights secured by law; or (iv) to combat community deterioration and juvenile delinquency."

Irrelevant Charges

Dr. Pierce then pointed out that the IRS charge of "racism" against NYA is completely irrelevant, since the IRS Code nowhere mentions this supposed sin. The fact that NYA's policies are based on racial considerations may leave it open to a charge of heresy from the high priests of the System's doctrine of neo-liberalism, but it has nothing whatever to do with NYA's status as a charitable and educational organization as defined by the IRS Code. Dr. Pierce's letter went on to say:

"You allege that NYA's 'racist policies include as their primary objectives the destruction of civil rights.' That allegation is false. The primary objective of NYA is, to the contrary, to restore to our people the civil rights they enjoyed before the present era of decadence and repression set in. "One must suspect that when you refer to civil rights you have in mind a different set of rights and a different group of people to whom you feel those rights should belong than NYA does. Have you made the judgment that 'civil rights' should be restricted in meaning to the 'rights' of Negroes to be schooled with, to work with, and to live with Whites?"

"NYA recognizes and strives to

defend a far more important and fundamental set of rights, namely, the right of individual and collective self-defense for White Americans; the right of racial self-determination; the right to freedom of association; the right to an honest, competent, and courageous government; the right to work, live, and raise one's children in a wholesome, healthy, and racially homogeneous environment; the right to preserve undefiled the cultural and genetic heritage of Western mankind; and many other long-established, though sometimes repressed, rights of our people.

"NYA has meritoriously chosen to defend precisely these civil rights whose defense has been largely neglected, or even opposed, by other tax-exempt organizations."

Twisted Meanings

Although the IRS charge that NYA looks upon violence as an acceptable means for gaining its ends is irrelevant to NYA's tax-exempt status as the IRS charge of "racism," Dr. Pierce's letter pointed out that the citations chosen by the IRS to establish this charge are less than convincing.

For example, the IRS quoted a long excerpt from the October 1973 issue of ACTION, NYA's membership bulletin. In its original context the passage quoted was part of an argument for the use of the courts, not violence, in attaining NYA's goals. That issue of ACTION was primarily seeking support from the membership for Dr. Pierce's current lawsuit in the Federal courts against Secretary of Defense Schlesinger as a result of Schlesinger's illegal transfer of U.S. military equipment to Israel last year. The relative ineffectiveness of past violence from the Right was cited as one reason for turning to other means—in this case the courts.

Data about Zionism

In response to the IRS concern over NYA's treatment of the Jewish problem, Dr. Pierce wrote:

"You are correct in your assertion that NYA materials include substantial amounts of data about the current objectives and activities of Zionism. NYA publishes this data as a public service, and it is in no way inconsistent with NYA's overall operation as an educational and charitable organization.

"You are also correct in your assertion that NYA's publications have alleged that 'the Jews, as individuals and as a group, are of questionable national loyalty.' This allegation, however, is backed by more than the 'disparaging terms, insinuations and innuendoes' you mention. It is also backed by facts, many of which you have recognized in NYA's articles on the current objectives and activities of Zionism.

"It is a common fiction in America that the Jews are people just like other Americans except that they go to a different church; that they have essentially the same values and objectives as other Americans; that they are no more ethnocentric and act no more in concert to promote their

special, group interests than do other ethnic groups, e.g. Scotch-Americans or Scandinavian-Americans; and that they do not have a divided national loyalty. This fiction is dangerous to the security and prosperity of all non-Jewish Americans, particularly in this period of Middle-East crisis, and NYA's publications have, from time to time, exposed this danger as a public service."

False Conclusions

In countering the false conclusions reached in the IRS letter, Dr. Pierce stated:

"The conclusions in your letter are wrong in every particular. As pointed out above, NYA does promote civil rights. Furthermore, NYA's civil-rights activity, far from begetting prejudice, has the effect of overcoming such prejudices as the unfounded belief that all races are equal and the superstition that racial mixing is socially and culturally beneficial to the races involved.

"Nor is the cumulative effect of NYA's publications the promotion of hatred, as you assert. At least, that is not the effect in normal, well-balanced persons.

"The intent and the effect of NYA's publications are to develop a sense of racial identity in persons of Western blood; to instill in them an appreciation of and a pride in their biological, cultural, and spiritual heritage; and to build bonds of love and racial solidarity uniting all men

and women of the West into a single, overwhelming force.

"NYA activities are educational as well as charitable, contrary to your assertion. NYA's educational activities include, but are not limited to, the distribution of newspapers, pamphlets, leaflets, and books setting forth and explaining the facts of race and of history in a manner consistent with NYA's aforementioned charitable activities. The works of more than 200 authors, many of outstanding historical or scholarly significance, are among the items distributed by NYA in furtherance of its educational goals. Furthermore, many of these items are not readily available from other sources accessible to most Americans."

Stifling Free Speech

Dr. Pierce's answer to the IRS concludes with the charge that "your letter is a manifest attempt to stifle freedom of speech and freedom of the press, as exercised by the members and staff of NYA.

"Viewed together with the publications and activities of organizations whose tax-exempt status you have not challenged, your letter clearly threatens: 'promote only those civil rights of which IRS approves; publish only those opinions with which IRS agrees; attack only those prejudices which IRS does not hold—or your tax exemption will be withdrawn.'"

Tax-Exempt Subversives

Approximately 600,000 organizations in the United States enjoy a tax-exempt status. The great majority of them are engaged in non-controversial activities to which the powers that be, as well as the general public, have no particular emotional reaction one way or the other.

But there are hundreds of them which are engaged in the full-time business of destroying America: some in the guise of religious organizations, others as educational, labor, or social-welfare organizations. Because these subversive groups have ties to the System, however, their status is never challenged by the IRS. Among these tax-exempt organizations is organized Jewry's secret-police agency, the ADL.

Hypocritical but Not Sued!

Actually, it is not surprising that the IRS, as an agency of the System, is unwilling to extend equal rights under the law to NYA. The System can hardly be expected to collaborate in its own liquidation. Thus, there is one tax law for those organizations ideologically in tune with the System and another tax law for those opposed to the System.

NYA is badly outgunned in its fight with the IRS, but there is a good chance that the fight, whether won or lost, will serve to expose to the public some of the hypocrisy and arbitrariness of one of the System's most oppressive agencies.

Political Police

borne. Patriots must consequently learn how to deal with harassment from the System's political police until such time as the FBI once again is restricted to its lawful and proper functions by a new government acting in the true interests of America.

The most important single idea for the patriot to bear in mind is that he must not let his awareness of the FBI's motives and tactics cripple his ability to carry out his own tasks in the struggle for a better America. He must avoid paranoia, a totally debilitating affliction, the seeds of which the System deliberately sows among its enemies.

Planting Fear

A recently published FBI memorandum explains that one of the reasons for the stepped-up program of FBI visits to the homes and places of employment of political dissidents is to let them know that Big Brother is always watching them. The memo goes on to urge agents to indicate that phones are tapped when they really aren't and that FBI raids are imminent when they're not. It concludes with the statement that the agent's goal should be to make dissidents fear "that there is an FBI agent behind every mailbox."

Such words may have a strange ring to American ears, but the author of that memo had a better understanding of the truthfulness of the average citizen in this era than do all the authors of our high school civics textbooks, with their jabber about democracy, human dignity, individual rights, and freedom of expression.

A Nation of Jellyfish

The average American has no stomach for standing up against the System's political police and insisting on his rights. It doesn't matter how many times he has been told that the police are the servants of the people and that, as a tax-paying citizen, he is their employer; when two hard-eyed men in business suits come knocking at his door, flash their FBI credentials, and inform him that they want to ask him a few questions about his political beliefs, his heart turns to ice and his legs become unsteady. Instead of becoming indignant at such a brazen intrusion into his private affairs, he becomes terror-stricken. Unreasonable fear causes him to imagine every sort of dire consequence, from loss of his employment to being held incommunicado in the basement of the Justice Department and tortured. The chances are that he will instantly resolve never again to say an unkind word about Big Brother, if only the System will leave him alone.

Dropouts, Informers

Thus, the simple tactic of compiling a list of the names and addresses of the activists in any troublesome organization, then making a call, at home or work, upon each one, can be counted on to permanently deactivate a certain percentage of the group. Those who are not deactivated will, nevertheless, tend to become jittery and suspicious and, consequently, less effective in their activity.

Finally, in every large group there will be a few persons of such weak character that they can be intimidated into becoming informers. FBI agents are

trained to spot these weak ones and to apply pressure to them as soon as they are spotted.

Never Be Defensive

After determining not to become paranoid, the second idea for the patriot-activist to bear in mind is the rightness of what he is doing. He must never let the System or its agents put him on the defensive.

Any member of our movement is doing what every White man and woman should be doing, but which most are too selfish or weak or ignorant to do at this time. He is, therefore, better than any employee of the System. He should not only know in his heart, but also show in his outward attitude during any encounter, that he is right and the System's man is wrong.

Know Your Rights!

The third thing to keep in mind is at least a rudimentary awareness of the protection still afforded American citizens by the laws. Theoretically, the political and ideological beliefs and activities of an American citizen are not legitimate concerns of the FBI. Unless the FBI has concrete evidence that a citizen has violated a specific Federal statute, it has no business investigating that citizen or his activities, beliefs, or associations.

That is the theory. In practice, FBI agents do whatever they are allowed to get away with. They, just like bureaucrats in the System's other agencies, will bully any citizen who is afraid to stand up to them.

The patriot-activist must always insist that the theory be upheld in every detail. If the FBI is not righteous enough to stick to its legitimate concerns, then we must help it avoid sin.

No Answers

Any member of our movement, upon being approached by an FBI agent who has properly identified himself, must first, before answering any questions whatever, ascertain the exact reason for the FBI's call. Unless the agent convinces the patriot that he is investigating a specific, non-political violation of a Federal statute — such as a narcotics offense or interstate transportation of a stolen automobile — and the patriot has specific knowledge which can help in the apprehension or prosecution of the criminal, the interview should be politely but immediately terminated.

No vague statements about an investigation of "conspiracy" or "violence" or "subversion" or, in fact, anything have the remotest possible connection to movement activities should induce a patriot to answer questions.

No Need for Justification

The right to privacy must be insisted on absolutely and, if necessary, indignantly and loudly. If a patriot has violated a Federal law and the FBI has solid evidence of that violation, nothing that patriot can say is likely to keep him from being arrested. If he has not violated a law, he need not try to convince the FBI of his innocence.

Never, under any circumstances, is he obliged to answer any questions, to justify his activities, beliefs, or associations; or to give any

sense of social responsibility. It has become a case of "every man for himself."

The result of a constant scramble by every group to get the biggest slice of the pie for itself, with a corrupt leadership which makes laws favoring whichever group is yelling loudest at the moment—or can pay the biggest bribe—is runaway inflation.

Wage-Price Spiral

One labor union extorts a huge wage increase for its members. All the others with sufficient muscle or political influence then try to follow the example set by the first.

Manufacturers then boost their prices to make up for their increased labor costs. Some take advantage of the general price rise to jack their prices up even if their production costs haven't increased.

accounting of himself whatever to an agent of the System.

Power of Publicity

One need not be obnoxious or arrogant about this, so long as the FBI accepts it graciously. If the occasion should ever arise when an FBI agent fails to apologize for his intrusion and make a hasty departure when politely informed that he has no business inquiring into the private affairs of a law-abiding citizen, the patriot should immediately, in the presence of the intruder, telephone the nearest FBI field office, ask for the special agent-in-charge, and complain vehemently.

If that does not produce immediate and satisfactory results, he should air the matter as thoroughly as possible in his local, daily newspaper and inform everyone else in a position of public authority, including his congressman. If there is one thing the FBI does not like, it is a public fuss. It shrinks from public exposure like a vampire confronted with a crucifix.

These price hikes eat up the workers' increased wages, and so they press for still further wage increases. It's a dog-eat-dog battle for survival, yielding the familiar wage-price spiral.

Great Soviet Grain Robbery

In addition to these general causes, namely, corrupt government and a breakdown of responsibility, there are also special causes of the present inflation. In particular, the skyrocketing of food prices during the last eighteen months was triggered by the sale of one-fourth of the 1973 U. S. wheat crop to the Soviet Union by grain speculators.

This sale forced domestic wheat prices up sharply. In fact, the price rose from \$1.66 per bushel in July 1972 to \$6.45 early this year, an increase of nearly 300 per cent!

The shortage of wheat also forced up the prices of other feed grains, especially corn. Since 80 per cent of the price of poultry, pork, and beef goes to pay for the grain fed to the chickens, hogs, and cattle, the grain shortage caused meat and poultry prices to rise most sharply.

As more and more Americans could no longer afford to buy meat, the demand for fish and other foods rose, forcing food prices up all across the board. The speculator primarily responsible for the sale of American grain to the Soviet Union is Michel Fribourg, the enormously wealthy owner of Continental Grain Company, the country's largest privately owned business enterprise, was started in 1813 by Simon Fribourg, a Jewish commodities speculator in Belgium and the great-grandfather of Michel Fribourg. In the last 161 years the company has remained in the Fribourg family and has gradually fastened a stranglehold on a substantial portion of the international trade in foodstuffs.

Fribourg has a multi-billion-dollar stake in the policy of "detente" between the United

States and the Soviet Union, which has led to vastly increased profits for his company. He also has a stake in other government policies which determine the size of his profits.

Worse than Watergate

Fribourg's role in influencing government policies to his advantage — and to the disadvantage of all other Americans — would cause a bigger scandal than Watergate if brought to the attention of the American people. Although there have been minor rumblings in Washington about certain aspects of the Great Soviet Grain Robbery, in particular the fact that shipments of the grain Fribourg sold to the Soviet Union in 1972 are still being made in the face of an impending wheat shortage in the United States this summer, the politicians and the media masters are generally keeping their mouths shut.

Curing Inflation

Even though we have inflation, the cure is not easy. The Federal government, of course, is scrambling for quick-and-easy, short-term remedies, and they will probably find a few. The only real solution, however, is to make some fundamental changes in the government itself.

Eliminating the present weakness of the Nixon administration through impeachment is not a solution, because a government which is merely strong is not enough. We must also have a responsible government, and the present corruption and irresponsibility permeate every branch of the government, not just the Presidency.

A new government, based on a profound sense of responsibility to the American people and with the authority to regulate commerce for the general good, is the first step. That in itself, however, will go a long way toward rebuilding the sense of social responsibility on the part of all the elements of our society which is ultimately required for a stable and fair economy.
