Dear Mr. Weisberg:

I am enclosing this ~ in the sack that I gathered from much more material by the curb at 802 W. 2nd, next door to here: (908). I explain, herein, in the papers.

2 weeks ago, my son Henry ~ would be 19 Sept. 30 ~ sat here on the bed where I am writing this and cried, saying he was scared, and now I do am left pondering.

The people around Henry ~ to whom the courts had turned him over, including one who he was to marry and she was 5 yrs. older than he ~ and they had a baby now a yr. and a half old. ~~She is close to a John Worrell.~~ Henry apparently has been judged, tried, executed without any concern for his life which would have been no doubt a long one. I am wrong about this again the evidence is overwhelming, and from what I know. He could have been murdered.

On that a.m. after the fire, after 9, a woman came by, called in. The fire dept. came "dutifully" put it out in the back seat of the blue, old, not late model auto - which had wiring on the door handle by the drivers seat. So in the paper next day the fire list #2 in enclosing a list (sample) here showed only that the 5:35 deal when I was awakened by a stuck horn and ran out to see flames inside the bright in the station with the horn incessant. I couldn't see any figure but noticed the horn let up briefly, they continued. I ran back in my landlady (77) called in - she said later, a rescue unit had arrived but I couldn't bear to watch, ran back inside. That was Sun. 9 a.m. this is 5 hrs. p.m. by the apt. I just gathered up this material by the curb. 9:10 est. house, owned by a Louis (or Louis) my shp said = when I mentioned to the S.T. they had made no correction. could be the remains of my son because that was the only pair of trousers he had. When I saw him above last, about 2:30 or 3 Sat. of the library where he had come after my landlady wouldn't let him stay. She also was in a month, in foul play too.

3 days later I saw a afro-haired young black in blue flowered shirt in the library - I needed a strong impression watching her also a - leg Mexican with a white winter cycl helmet, on a tall, I thought possibly be her a brother to "Fred" (or Chase?) ?? note: # responsible could be a Mrs. Chastain, or Jean, or a woman, Baber, "Washella".

There have been 4 yrs 5 1/2 months of living to see what would be.
