Thanks for your memo and remembrance of Greg Stone. I've learned a bit more.

His sister is a clinical psychologist living in Miss. I do not know her name or address. There is to be a memorial this weekend in L.A., perhaps at the home of and if not with the involvement of the UAW's Paul Schrade. He and others below may know.

Last evening I was phoned by Paul LeMat, about whom I remembered nothing. He'd visited me years ago. Afterward I phoned Roger Peinman, who has been working effectively with Jerry Policofft to learn more and he'll convey the information to Jerry. LeMat's phone is 213/278-6101. His friend and apparently Greg's closest friend is Floyd Nelson, also Greg's neighbor, 666-6148. Nelson has the will and a note with it. The other notes are in police possession. LeMat works in movies, as does his wife. I ask you to make no mention at all of what follows because I have hopes for it and want no intrusions. The wife has some connection with Oliver Stone and expects to have his script soon. He'd try to get me a copy. I promised written comments. *All Garrison.*

LeMat says that Greg had had suicide in mind for some time but this either had not been detected by friends or if detected not anticipated. Because they were concerned about his state of mind LeMat got him to see a psychiatrist who specializes in the problems of ~~the~~ movie people. Greg was going to see him and he was also involved in group therapy for children of alcoholic parents, both sexes. It was Greg's father, I am not sure because I did not at first make notes but I think this is a Dr. Fields. Greg did have a controversial drug prescribed, Prozac (or K). Roger was disturbed on hearing this because he knows of that medication what I do not know. LeMat said that there is a current lawsuit over it out there, by the wife of a man who alleges he was driven to suicide by it. The prescription is dated 1/17. Nelson found an empty container for this medication and a started one but it has the name of a different doctor.

Roger's phone, by the way, is 718/526-2302. When he is <sup>not</sup> in a machine records messages. *Fine fellow, good friend, very close to Sylvia Meagher for years*

I don't know the details, but LeMat also spoke to Dan Moldea, who had written articles based on Greg's work. Good articles, with his own inquiries added.

Those of Greg's papers relating to Allard Lowenstein go to his archive in S.C. LeMat recalled no reference to Sylvia's papers. Absent a will, Roger thinks this may give his heirs control. He also says that all they have heard says that Greg intended the temporary Hood deposit to be permanent.

I've asked LeMat to send me all the info. he can. He says he will.

Greg's interest in getting a .22 Iver-Johnson pistol was to test penetration in wood to duplicate that part of the assassination investigation. If it was gotten for him by the part-time Hood student, Rachel Weatherly (approx) she sent it through a dealer, so he got it, if he did get it, from a dealer in L.A., as Le Mat told me.
