Dear J.B. Stener,

Sorry this got lost in the stack on my desk. If he did what I asked him to do before I got these extra copies Jerry should have sent them to you.

I heard from him today. He still talks and thinks like a child. I'm sorry for him.

Jimmy appears to have flipped out entirely.

I have some information from several dependable sources.

When Freed and Cohen phoned you they were using what is called a psychological stress evaluator. When they asked you if you had known Jimmy earlier than he said they were hoping the machine would show you were not telling the truth. In my opinion these machines "say" whatever the operator wants them to "say."
