My thoughts have been with you often. Hope you are well.

What relationship this had to the King killing I never fully understood, except that it was cited on the Milster tape as being the work of a man who "tried to get King."

Stoner's part in the whole affair is by far the most intriguing. He is a loathsome but interesting man, in the sense that Goering, Himmler, Ribbentrop, etc., were, <sup>BUT ON A</sup> <sup>LESSER SCALE.</sup>

I am not able to determine how much the Washington papers carried on this. Some papers are missing, it seems. At any rate, I'm sure you got the highlights. The local papers here carried virtually nothing on it. (They are controlled by a wealthy right-wing family who generally blackout anything against the Klan.) Also, nothing in the Dallas or Memphis papers, and only one story in the Atlanta paper, as far as I can tell. The basement is dimly lit.

The Birmingham paper is by far the best and most extensive. What little else there is, was copied from these. Unfortunately, we only have <sup>OUT OF</sup> <sup>STATE</sup> papers from the preceding month, due to limited space. Otherwise I would check the August papers to see who was subpoenaed before the grand jury. I was unaware of this investigation.

I am very good at this sort of thing, digging, etc., as you see before you. This is one favor I will never forget.

Even though it may <sup>TURN OUT TO</sup> be a sham, it could still be productive to have me on the inside. This committee, I understand, has unlimited access. And I on the inside could get you anything you want & can't otherwise get.

Please write me as soon as you can and let me know how you are doing. Has your left leg gotten any better? Have they diagnosed the other problem in your right foot?

I imagine you still exercise each day.  
I'd like to take another set of walks  
on your driveway with you sometime.  
I just don't know when I'll be  
up that way again. Things are quite  
up in the air at this end. But we'll  
keep in touch.

I am praying for your legs  
to be healed.

I have located a paperback  
of Julia's Story, by Fred J. Cook,  
but I will not get it for you  
unless you say you want it when  
you write back. It is a tragic story  
of medical arrogance/incompetence and  
negligence. She had had heart surgery,  
and was on Coumadin to prevent  
clots. ~~She~~ She died because her blood  
got too thin and the pompous ass  
doctor <sup>had been</sup> ~~was~~ too high and mighty to  
observe all the classic symptoms. He  
also failed to impress upon them the  
urgency of having the blood tested  
at least every week. I personally  
witnessed the fact that you take great  
care to do this.

I just hope it all straightens  
out before long. My sincerest best
