DEAR MR. WEISBERG:

I APPRECIATED YOU SENDING ME 'WHITEWASH IV' DIRECTLY - SAVED A DELAY IN ORDERING. PLEASE FIND ENCLOSED THE REQUIRED AMOUNT FOR THIS BOOK. I AM READING THIS ALOUD TO MY HUSBAND IN THE EVENINGS; AND WE ARE WELL INTO IT. BOTH OF US ARE VERY INTERESTED BY WHAT YOU HAVE WRITTEN AND FINDING IT HARD TO PUT DOWN. I HAVE BEEN READING QUITE A BIT LATELY ABOUT THE INTRIGUES OF GOVERNMENT, AND YOUR BOOK ADDS TO MY KNOWLEDGE. I FIND IT ALL EXTREMELY DISTURBING AND FRUSTRATING; AS THERE IS SO LITTLE THE AVERAGE PERSON CAN DO ABOUT IT. I HAVE BEEN ENCOURAGED THESE PAST MONTHS HOWEVER, BY THE NUMBER WHO SEEM TO SUDDENLY BE CAUGHT UP BY THE UNIVERSAL CONSCIENCE OF TRUTH; AND WHO ARE WORKING DILIGENTLY TOWARDS THIS GOAL - PERHAPS IT IS THE NEW GENERATION TAKING OVER AS THEY SAY. WHATEVER IS THE CAUSE - IT COULD NOT HAVE HAPPENED WITHOUT THOSE, LIKE YOU, WHO CARED ENOUGH, TO PURSUE THIS FROM THE START. MY WARMEST REGARD AND RESPECT FOR WHAT YOU HAVE DONE.

I AM GOING TO SEND THE ADVERTISING FORM YOU ENCLOSED, TO MY HOST ON THE KABC TALK PROGRAM IN LOS ANGELES. HE EXPRESSED INTEREST IN THE KENNEDY CASE AND HE MAY NOT BE AWARE OF YOUR NEW BOOK ON MARTIN LUTHER KING. LATER WHEN FINANCIERS ALLOW I WOULD LIKE TO PURCHASE THIS BOOK. I AM ALSO INTERESTED IN THE OSWALD BOOK YOU ARE WORKING ON. IT IS OF COURSE BADLY NEEDED, TO SET THE RECORD STRAIGHT.

P.S. I AM REGISTERING THIS LETTER, TO INSURE THAT YOU WILL RECEIVE THE MONIES. THE THOUGHT JUST OCCURRED TO ME, THAT SHOULD THIS LETTER GO ASTRAY - YOU WOULD WONDER WHY I HAD NOT SENT PAYMENT AND I WOULD NOT KNOW YOU DID NOT RECEIVE IT - BEST TO BE ON THE SAFE SIDE. I'VE BECOME RATHER PARANOID ABOUT THE MAIL, EVER SINCE AN EXPERIENCE I HAD WITH A MR. RUSTY ROADS - COMMITTEE TO INVESTIGATE ASSASSINATIONS, IN LOS ANGELES. A NUMBER OF MY LETTERS NEVER GOT TO HIM AND HIS NEVER GOT TO ME; UNTIL I USED THE REGISTERED WAY. IT HAPPENED AT THE TIME, WHEN MR. ROADS WAS ENDEAVOURING TO OBTAIN NAMES TO PETITION THE LEGISLATURE TO RE-OPEN THE ROBERT KENNEDY CASE. I HEARD HIM ON AN EVENING TALK PROGRAM AND WANTING TO HELP OBTAIN NAMES; I WROTE FOR A PETITION FORM. IT TOOK ABOUT SIX MONTHS TO FINALLY GET THROUGH TO HIM - SO I WASN'T MUCH HELP. MR. ROADS TOLD ME THAT STRANGE THINGS HAD BEEN HAPPENING TO HIS MAIL. IT SEEMS NOTHING IS SACRED ANYMORE.

THOUGHT YOU MIGHT BE INTERESTED IN THIS, AS IT CONCERN'S YOUR WHITWASH BOOK. I TAPED IT FROM THE MICHAEL JACKSON TALK FORUM, KABC, LOS ANGELES. A CALLER PHONED AND MENTIONED WHITWASH AND THAT IS HOW I FOUND OUT IT WAS AVAILABLE. I OFTEN TAPE MR. JACKSON'S PROGRAM, SO MY HUSBAND HAS SOMETHING INTERESTING TO LISTEN TO AFTER WORK. THE FOLLOWING IS TRANSCRIBED FROM MY TAPE RECORDER.


CALLER \* THERE'S A NUMBER OF BOOKS CALLED THE WHITWASH BOOK. THE LATEST ONE I READ ALOT ABOUT IN THE FREE PRESS AND I STARTED LOOKING ALL OVER LOS ANGELES TO TRY TO GET, AND NONE OF THE BIG BOOKSTORES HAD IT, FINALLY I CAME ACROSS A COPY IN A LITTLE PAPERBACK BOOKSTORE IN WEST LOS ANGELES, CALLED "PAPPABACK" AND THEY HAD A COPY OF THIS WHITWASH IN, AND I SUBSEQUENTLY SENT BACK TO WHISPERS AND HE SENT ME ANOTHER COPY, BUT ONE OF THE POINTS I WANT TO BRING OUT - THAT BOOK WAS ABOUT A SUIT HE HAD AGAINST THE NATIONAL ARCHIVES - THE UNITED STATES GOVERNMENT ON THE FREEDOM OF INFORMATION ACT, TO RELEASE TO HIM, WHAT IS CLASSIFIED AS TOP SECRET BY THE WARREN COMMISSION HEARING, WHERE THEY GOT INFORMATION THAT OSWALD WORKED FOR THE F.B.I. AS AN INFORMANT AND THE C.I.A. AS A CARRIER. NOW THIS WAS ALL IN THIS ONE HEARING: A CLOSED MEETING OF THE COMMISSIONERS OF THE WARREN COMMISSION. MADE UP OF THE SIX COMMISSIONERS WHO ARE GERALD FORD, ALAN DULLES, RICHARD RUSSELL, JOHN SHERMAN COOPER, JOSE JAMES MCCALL AND HALF BOOGS, AND THEIR ATTORNEYS OF THE STAFF. NOW HE HAD TO GO TO COURT - U.S. COURT AND I THINK IT WAS JUDGE SERICA HEARD HIS CASE AND LEONARD JESCHILL. LAST YEAR THEY FINALLY RELEASED THIS TRANSCRIPT OF THIS HEARING, AS TO WHETHER OSWALD WAS FBI. THIS BOOK CONTAINS ALL THIS INFORMATION, PLUS THE LETTERS OF THE SUIT AGAINST THE GVT. THAT IT HAD TAKEN HIM TO GET THIS INFO. SOMEBODY LIED IN THAT HEARING. I'LL CALL YOU BACK AND LET YOU KNOW WHO ONE OF THE ASSASSINS IS AND WHO HAS INFORMATION ON JOHN KENNEDY. THIS IS A FACT AND A STRANGE STORY AND THIS MAN DOES NOT KNOW HOW TO GET IT OUT TO THE PUBLIC, IN FACT I HAVE DICK GRUGGIES (UNINTELLIGIBLE), WHO IS AN INVESTIGATOR - ART SOLMAN - MET THIS MAN WHO WAS IN THE CIA.

MICHAEL: YOU WANT TO SAY TO ME RIGHT NOW ON THE AIR -----

CALLER : NO, NO, I WOULDN'T USE ANY NAMES ON THE AIR, AS I ALREADY SAID, THIS MAN DOES NOT KNOW HOW TO GET THE INFORMATION OUT, WITHOUT HAVING A (UNINTELLIGIBLE) ON HIMSELF AND HE WANT TO HAVE A PACKAGE OF CYANIDE PILLS IN HIS PACKAGE - BE LIKE IT OR NOT - IT SOUNDS WILD - I'LL CALL YOU BACK ANOTHER TIME.

I DON'T KNOW WHAT THAT LAST PART IS ALL ABOUT, BUT THE CALLER DID GIVE YOUR BOOK QUITE A NICE BIT OF PUBLICITY\* ALL THE WAY OUT HERE ON THE WEST COAST.
