Dear Mr. Weisberg,

Please let me introduce myself; my name is Joseph Traphagen. I live in Liverpool, New York, a suburb of Syracuse. I am married with 3 children and one grandchild. I am 43 years old, a Viet Nam veteran and have worked in the telephone industry for 20 years. I was 14 years old at the time of the JFK assassination. I am a student of history and consider that crime to have changed the course of history.

I have long been intrigued by the case and recent events have served to rekindle interest in it. I have read several of the more recent books on the assassination and have seen the documentaries that you appeared in ("Investigative Reports", etc.)

I am currently reading "High Treason 2" in which, apart from the mention of "back of the head" approximately 1000 times, some interesting questions are raised.

Being an amateur researcher, but having a lot of historical knowledge of the case, I would like to ask your opinion of some questions raised in more recent years. I understand from speaking to your wife on the telephone this evening that you

are having some health problems, so if you are
unable to help, I understand.

First, let me say that my opinion is
that there was and continues to be (and continues)
a conspiracy in the JFK murder as well as King and RFK
Watergate, etc. I believe there were at least 2 shooters
in Dealey Plaza and that although the Mafia (or mob)
may have provided technical assistance, the crime and
the continued cover-up had to be carried out at the
highest levels of the government. I also believe that
~~Oswald was a patsy~~
My questions for you are:

- Shooters - 1) They may have been professional CIA assassins
and/or Cuban. What do you think of Steve Livell's
report about Corsican hitmen hired by Marullo/Significant
versus Terrie allegedly meeting Cuban killers?
- 2) Gordon Arnold's encounter with "bodge man" at Grassy
Knoll. Did anyone ever ask him to describe the man
or his voice or show him a picture of Lee Harvey Oswald?
- 3) The very end of the Zapruder film follows the limousine
into the overpass. Doesn't this show the wooden fence
area of Grassy Knoll where shooter supposedly was?
- 4) What is your opinion of Bonar Menning's book
"Mortal Error" stating that Secret Service agent Hickey

fired the pistol that had shot (this book ③ assumes, however, that Oswald was the only shooter.)

Medical evidence) David Lifton theory of surgery done to President between departure of body from Dallas and arrival at Bethesda (air force major "body not logged in, second casket, etc.) Is attention such as this possible, so as not to be detectable?

2) Would exhumation of JFK body solve anything after all this time? Garrison Livingston raises the question of who is really in JFK's grave.

Kennedy family would strongly oppose, but, if an investigation into JFK murder warranted exhumation, could legal circumstances override family and force exhumation? Is it possible JFK remains were switched with or buried as "air force major" that was supposed to be buried in Arlington Saturday 11/23/63?

3) Did JFK have Addison's or Pott's disease? Would he really have not lived through second term?
