Dear Mr. Mealey.

by this time I think you know me well enough to believe that I am asrious in my purposes, thorough in my researches and investigations, and no ones yes-man. In writing you when I have so many things I so much want to do I cannot complete them all, I tell you I have in this case no purpose other than what I regard as your interest. I have two things in mind.

These are what you do to yourself and to truth with your continued promotion of the perjurer, racist, irrational extremist of the extreme right who is the friend of your enemy and to let you know that, eside from the charge Gerrison has placed against Shaw, of perjuries, I am satisfied there is still another and entirely irrefutable one in which he is not alone involved. My information on this is entirely official; Further, there is yet another in which my information is not official but is dependable, from pro-Shaw sources.

I cannot begin to tell you why Carrison failed to make use of these things during the trial. Possibly in the intensity of the proceeding they were overlooked.
