Assassination conspiracy conference set at UCLA

plied by Don Freed, Jim Cookson and Jeff Cohen, of the Campaign for Democratic Freedoms.

The ruling circle's split over the JFK assassination is reaching Watergate proportions. Frank Manklewicz and other, former high-ranking Kennedy aides are being briefed on the assassinations of both John and Robert. In Texas, former Dallas Police Chief Jesse Curry has called for a new Investigation, as has Dallas D.A. Henry Wade, Texas Congressperson Gonzalez, former Senator Yarborough and even the U.S. Attorney in Dallas, Kenneth Meighell. And the Dallas Morning News has run a story on organized crime's link to the murder.

Meanwhile, in Los Angeles, the newly formed Campaign for Democratic Freedoms has planned a conference that moves from scrutiny of the assassinations to the war conspiracy to the local level: LAPD's dreaded Criminal Conspiracy Section (GCS). By the end of the UCLA conference, participants will have organized themselves into community groups. These ongoing units will combine to prepare class actions and a general political-legal attack on Los Angeles' Blue Machine, which is even now racing to secrete sensitive dossiers.

New evidence will be presented at UCLA concerning the far-reaching conspiracies of the LAPD's Criminal Conspiracy

Involvement in the murder of both Jonathan and George Jackson, James Carr and attempts on the life of Huey Newton.

Involvement in the formation or coverup of terrorism in California - together with at least three other state and federal agencies.

Penetration of the entire Southern California criminal justice system by agents of the Central Intelligence Agency and the Howard Hughes organiza-

- Suppression of evidence in the assassination of RFK and the presence of L.A. police, under CIA control, in the coverup.

LAPD (CCS) cooperation with and protection of neo-Fascist terrorist attacks on Los Angeles popular groups such as the Socialist Workers Party and the Rosenberg Committee.

- Blackmall dosslers on the highest ranking elected officials in L.A., including Mayor Tom Bradley, their families and staffs.

 Possession of blackmall files on both reporters and management of local media, including the L.A. Times.

The following is a partial review of the events which the UCLA conference will examine.

"I'm just a patsy. I didn't kill

anyone." Lee Harvey Oswald Something happened. America lost a weekend in November 1963. And the public execution of the lone accused shifted the burden of fact-

finding from a jury of peers to a Presidential commission and the national media. A reluctant Chief Justice was persuaded to head the investigation to squeich rumors of international conspiracy and "save America from atomic war." Attorney Mark Lane, counsel for the accused's mother, was barred from cross-examining

witnesses. There was no time. This verdict had a deadline the 1964 elections.

"[It was important to] show the world that America is not a banana republic, where a government can be changed by conspiracy."

- Warren Commissioner John J. McCloy the Report explained the events of the lost weekend in Dallas through the unfortunate acts of two lone nuts. Oswald had no ties to U.S. Intelligence. Ruby had none to the underworld. Dallas grinned.

Commission exhibit 399, an unmarked bullet, inflicted seven wounds in the president and Governor Connally and shattered two bones. America's best marksmen could not duplicate Oswald's accomplishment. The autopsy doctor burned his notes. Europe chuckled. The Third World cackled.

"I never believed that Oswald acted alone.

national media was unprecedented. The New York Times halled the Warren Report as the "final truth" after "the most painstaking, exhaustive investigation." The dissenting investigators who pored over

the 26 volumes of evidence were labeled "scavengers." For two years, no major media outlet would air one word of doubtl. The Report was above debate in the corporate media.

The loudest silence came from the progressive press which had just begun to speak out against the Red purges and racial discrimination of the fif-

ties. Not since the Rosenberg frameup had progressives been so slow in reacting to official deception. Relieved that the commission had not found a Leftist conspiracy behind the "pro-Castro defector," progressive journals were happy to forget about the whole affair. Hadn't the unimpeachable Earl Warren headed the commission?

ed. I ne siremanye press, which had grown up slongside the radical movement, represented the plaining Dallas in the light of Watergate, and vice verse, as a decade of profoundly dirty tricks.

The gunplay that removed George Wallace from the presidential race marked the third straight time that buillets, and not ballots, had decided the election. Wallace house sides that the White House plumbers were behind his attempted murder.

releases as "final truth," was shaken by Watergate, CBS newsman Dan Rather, one of the commission's most ardent supporters, had risen quickly from a local Dallas reporter to anchor-man Cronkite's standin. Rather is the only Zapruder film viewer known to have described the President's head as driven forward by the fatal

shot. A nationwide TV audience heard Rather's description. They were not shown the film.

After 10 years of orthodoxy, Rather's CBS commentary, "Rethinking the Unthinkable," called for reopening the John Kennedy and other assassinations on the chance that Watergaters might be linked to the murders.

"The Watergate bugging is only one of a number of highly Illegal conspiracies engaged in by one or more of the defendants ... These as yet undisclosed crimes, can be proved."

Howard Hunt And there are links: three FBI documents in the Warren Commission files explore a meeting between Watergate's Frank Sturgis and Lee Oswald In Miami within two months of the Dallas murder. A conservative French paper, L'Aurore, reported that a mercenary, Jose Luis Romero, has identified Watergaters Bernard Barker and Sturgls as the two CIA men who approached him in Paris, soon after the Bay of Pigs flasco, about a JFK murder plot.

"I'd like to splinter the CIA in a thousand pieces and scatter it to the winds."

John F. Kennedy Victor Marchetti, the ex-CIA officer who authored the first American book subjected to prepublication censorship, has revealed that Clay Shaw was, in fact, a CIA contact and that Director Richard Helms expressed an Intent to help Shaw and his defense team during the trial. There was help: a federal judge barred Garrison from prosecuting Shaw for perjury; the Attorney General ordered FBI agents not to testify; and a 'company" agent looted the D.A.'s files.

Garrison, whose office was victimized by a domestic CIA operation, has stated his readiness to join with Marchetti in exposing Helms & Company before Frank Church's Senate

committee.

Philip Agee, CIA station chiefturned-revolutionary, surfaced in London where he has published a book that is banned in the U.S.A. Among other things, Agee disclosed that it is not uncommon for CIA personnel to be ordered to eliminate other "company" employees who are deemed dangerous or expendable.
