 THE FOLLOWING IS THE ENTIRE SCRIPT OF ANIONIO VECIANA'S INTERVIEW BY VIC WALTER, TV, CHANNEL 7, ON NOVEMBER 21, 1977:

"VIC WALTER: SEVERAL WEEKS AGO WE DID A NUMBER OF EXCLUSIVE INTERVIEWS WITH ANTONIC VECLANA, A MAN WHO IS KNOWN ONLY AS MR. X WHEN HE GAVE TESTIMONY TO THE HOUSE SELECT COMMITTEE ON ASSASSINATIONS. VECLANA DIRECTLY LINKED THE CIA TO THE DEATH OF FORMER PRESIDENT JOHN KENNEDY BY TELLING CONGRESSIONAL INVESTIGATORS THAT PRIOR TO THE KENNEDY ASSASSINATION HE MET WITH A CIA AGENT AND LEE HARVEY OSWALD IN DALLAS, TEXAS. SENATE INTELLIGENCE SOURCES SAY VECLANA IS PROBABLY THE CLOSEST LIVING LINK TO THE KENNEDY ASSASSINA-

VIC WALTER: DID THE FBI OFFICER EXPLAIN WHY THERE WAS A THREAT ON YOUR LIFE, WHY SOMEONE WAS OUT INYING TO KILL YOU? ANTONIO VECIANA: WELL I ASKED, I AM VERY WORRIED BECAUSE IT'S MY LIFE, I ASKED FOR INFORMATION. DETAILS AND THEY SAID, I CAN'T GIVE YOU ANY INFORMATION IT'S ONLY A WARNING AND YOU NEED, I AM TRYING TO PROTECT YOU. VIC WALTER: SO THEY JUST GAVE YOU A WARNING AND THAT WAS ALL THEY TOLD YOU. ANTONIO VECIANA: THAT'S THAT'S ALL THAT HE SAID. HE SAID, WE ARE TRYING TO PROTECT YOUR LIFE. VIC WALTER: SO YOU ARE UNDER PROTECTIVE CUSTODY NOW? ANTONIO VECIANA: WELL I SUPPOSE, THEY ARE TRYING TO PROTECT ME. BECAUSE IF THEY ARE GIVING ALL A WARNING IT EECAUSE HE HAS ALL THE INFORMATION AND THE DETAIL, YOU KNOW. I DON'T

VIC WALTER: THE FBI HAS CONFIRMED THAT VECIANA WAS WARRED ABOUT A POSSIBLE ASSASSINATION ATTEMPT ON HIS LIFE HOWEVER, THEY REFUSED TO GIVE OUT ANY FURTHER DETAILS, LIKE WHO WAS BEHIND THE PLOT. WHEN WE CONTACTED MEMBERS OF THE HOUSE ASSASSINATION COMMITTEE IN WASHINGTON, THEY SAID THEY WERE SHOCKED TO LEARN ABOUT VECIANA'S VISIT TO THE FOI OFFICE AND EVEN MORE SHOCKED TO LEARN THAT HE MIGHT BE KILLED BY SOME UNKNOUN ASSASSIN ON ASSASSING. THE SOURCES SAID THAT VECIANA IS CONSIDERED TO BE THE MOST CREDIBLE WITNESS IN THE INVESTIGATION OF PRESIDENT JOHN MENNEDY'S DEATH. THEY WENT ON TO SAY THAT HE IS SCHEDULED TO RECEIVE ANOTHER SUBPORNA IN CONNECTION WITH HIS PREVIOUS-TESTIMONY REPORT THE SPECIAL CONGRESSIONAL COMMITTEE, HOWEVER, IT IS NOT YET DETERMINED IF THE SUBPORNA HAS ANYTHING TO DO WITH THE THREAT AGAINST HIS LIFE. I'M VIC WALTER REPORTING FOR CHANNEL 7 NEWS."
