Dear Hal =

I received your letter in which you requested information I might have on someone trying to sell the Whitewash series based on what Roger Feinman told you some time ago.

Although you wrote that I would know who this is I may well know the individual involved but unless I was given the name I am not sure who you are referring to.

The one possibility I can think of (and to search through all the stuff I have would take a lot of time) is - TOM DAVIS BOOKS, P.O. Box 1107, Astor, CA. 95001.

If my memory serves me correctly, I believe some years back I saw a notice in his catalog that there was going to be available a complete book which would include all of your "Whitewash" series. I cannot, however, recall the name (or group) that was going to put this out. And if my memory also serves me correctly I think I wrote you about this at the time and asked if you knew what this was about. I believe you said

in a reply to me that you didn't know who was doing this but you may have asked me to keep an eye out if you (meaning myself) received further word on this. I never did see further word mentioned in that catalog so I forgot about it. My guess is that if anyone would know about this it would be the Tom Davis Books in Aptos. I once tried calling him asking the operator for his number but there was no listing. This was a few years back.

The second best place to see if someone would know about this would be, in my opinion, AL MARK & CO. BOOKSELLERS, P.O. BOX 7, Thornhill, Ontario L3T 3N1, Canada. Al Mark is the owner & he is a very sharp, astute individual and I'd bet he would most likely know.

There are two other book dealers who deal heavily in JFK items and you may wish to contact them. These are -

Out of these 4 possibilities you might be able to locate who the individual (or group) is.

I'm enclosing a 4 page document on Larry Schiller which you may or may not have seen before. I received them from Jim Di Eugenio who wrote the book on the Garrison case, "Destiny Betrayed". Jim asked me to send it to you as I had previously mentioned (to Jim) that you wanted to see the document on Schiller.

Di Eugenio also asked me another favor. Apparently

he will be going down to New Orleans this coming August and is continuing his research.

Jim was extremely interested in a comment I had made last Christmas when Jim & I were invited over to Aguilar's home for a meeting. We had been discussing David Ferrie & I had mentioned to Jim that Ferrie had even drafted his own FBI report. In a later correspondence with me after I mentioned this Jim asked me where I got this from. I told him I had read this in your book, "Oswald in New Orleans" (see page 188).

Jim then wrote me that he would like to talk to you (by phone) & discuss with you 2 matters. The first is, of course, the Ferrie written FBI report, and the second is your inquiry about "Farewell America." I know that he has never spoken to you before (so he says) & right after I finish this letter I'll write him giving him your address & phone (and best time to call you). So you can expect a phone call from him in the near future.

I have a lot of items to send you, but simply haven't had the chance to xerox them. I'll have to do it after I come back from a short vacation in the L.A. area. I'll be back on April 18th but then I have my cable TV show to do on the 20th. That show will be my tenth I've done with 4 more in the works. Walt Brown couldn't make the 7/20 show so he's sending me a video of him being interviewed. I've got someone else for the 20th show. Wallace Mlam also

will send me a video (on the ML King case) but not until after June 15th.

I received a call from NBC television in Burbank & they want to see some examples of my shows so when I visit L.A. I'll hand deliver them to their offices. It's better than mailing them, I think. I don't know what use they'll make of them but I intend to find out.

Well, I'll close now but I'll be in touch later on this month.

Oh, one final thing before I forget. As I was browsing through a bookstore I came across an Oxford edition of a biography of World figures. The edition was edited by none other than Kermit L. Hall. Hall must be the same as the one on the AERB. I noted the entry he had on Earl Warren in this book. There were three things he noted that stood out. First, that LBJ "persuaded" Warren to be on the Warren Commission though Warren didn't want to; second, that Warren did not receive certain FBI & CIA documents hindering his "investigation" & third, that Hall (or whoever wrote this section on Warren) stated that Warren should've followed his instincts and not have joined the Warren Commission. I think we should keep this in mind when venting to Hall & other members of the board. Is Hall going to be put in a position of saying that Warren should apologize to all of us for conducting a "bad" investigation & "revising" history? Let's see Hall squirm out

of this position if he is confronted with his own
