Had he not been of the right he'd have been fired much earlier and possibly prosecuted. He was part of the campaign to rid the government of all notto the right of sensis Khan. And he did it in violation of law and people's rights. What you say about COPA behavior is probably Judge being himself. The Aguilar-Cun inghman reference to that Burkley me memo questuong whether Oswald was alone I'd like tokee if you have it. Also that LBJ memo saying the pathologists were leaned on. Scott is right in saying the agencies will outwait the ARRB.

I've not heard from or about Bib Castorr in many years. He and his wife deparated. Last time I remember seeing him was at the 75th birthday party for the man with the recording business and he was quite a few years older than I. Castorr had friends in this area.
