Dear Mr. Wells,

The CBS shows are the videowhitewash, AP's stories the syndicated whitewash, and these will continue until citizens make their voices heard. CBS boycotted me on purpose. They stole their show from what I first brought out in WHITEWASH, my first book, credited others with it, and therefore would have been embarrassed to mention my name. They did ask for my permission to use some of my evidence. I gave the permission and photocopies of the evidence. I used them in the enclosed flyer. CBS was afraid to use the documents, afraid to mention me. They read WHITEWASH in the original limited edition.

My opinion of Garrison is not unprejudiced. I am all for him. What he is looking into comes from my work, chapter 11 of the first book, 7 of the second, and a considerable amount unpublished. My own book on that was to have been done by Dell. They broke their contract. After some delay my agent has arranged for a small publisher, Parallax, to do it. I hope it will be out soon.

I have been saying all along that Oswald was connected with the right-wing Cubans who were involved in the assassination and framed him. Garrison now says this also. Oswald had CIA connections. My New Orleans book is entitled CIA WHITEWASH: OSWALD IN NEW ORLEANS.

I think you will find that the book I am now publishing (enclosed flyer) and what I still plan will bring more information to light.

I agree with your comment on the attitude of the electorate. I also believe that unless people make their complaints heard, they must also share some of the responsibility.
