Dear Mr. Wilbur,

Thank you very much for your compliment and the copy of Whitewash.

I have an immediate use for the book because the xerox editions are too costly to lend out. One of the custodial staff of the mall at which I have walking therapy every morning expressed an interest in reading it after being given a copy of the crappy potboiler by the English seer, Sybil Leek (approx).

Professor Wiesman's reaction is typical and whether or not calculated is the reaction of the Eastern intellectual community to LBJ's appointment of a Commission headed by Earl Warren, with no follower of JFK among its members and the atypical 5-7 majority of the minority party.

What you refer to as your dossier numbers is provocative. Being in FBIHQ 124 filing indicates that you were an employee of ICA or a similar agency engaged in helping other countries and being in 134 indicates that there is an involvement of security informants. You also list a Secret Service Miscellaneous file, and I take it that 2591-61 USDC-DC refers to a case in DC federal district court. The two FBI 62 files relate to administrative inquiry, I presume about you, involving Washington and the field office of your residence. Whatever it is, I take it that the case is civil and that you refiled it in 1982, so good luck!

I am not at all sure that "most of those 'at the top' know perfectly well (most) of what happened" if by this you mean who killed JFK or who was part of the conspiracy. Certainly and from the outset there were many who knew the crime was beyond the capability of any one man and that the shooting attributed to Oswald was so impossible the best shots in the world were not able to duplicate it. But this provides no identifications and a perceived political need to cover the whole thing up can explain aborting any real investigation.

You are correct, we do not know the "why." Toward the end of my second book (about 8 or 9/66) I believed that thinking along the qui bono line might be productive and go into this in its epilogue, but then I realized that there were too many who could have, as they saw it, profited. However, the effect of that assassination is beyond reasonable question and after considerable research I planned a book addressing this. The effect was that of a coup d'etat. Policies, not the head of state, changed; and that was quite predictable. In this connection, what is little understood is that for the year before he was assassinated, JFK's international policies had changed and were changing further. He indicated where he wanted to go in a speech at American University about 6/63. His "we breathe the same air" speech with regard to the USSR, a peace speech. Just before the assassination he ordered the staged liquidation of our involvement in Viet Nam. There was only the briefest mention in the papers. When I interviewed him General Gavin confirmed this to me and added detail, for JFK had called him and other generals in to explain his purposes.

It is unfortunate that there was such an outpouring of utterly irresponsible conspiracy theorizing in books that found ready publication and elsewhere because all of that crazy crap served to confirm to the abdicated intellectuals that their first impression was correct. It also served to discredit the few of us who were not pursuing whodunits.


I appreciate your writing to me rather than telephoning, and am pleased that you recall my seminar at the University of Chicago. I also appreciate all that you have accomplished in your long career.

However, as my wife explained to you, I have never had any doubt about Oswald's killing of President Kennedy, not since the first announcement. Not having any bigotry about the South, I did not blame "Dallas." I learned very quickly that Oswald had been a Marine, but had never learned to drive a car; that alone made him seem odd to me. It would be less odd if he had come from New York, but he came, as you know, from Louisiana. But an interest in conspiracy theories vis-à-vis the Kennedy assassination is not one of them.

As I think you realize, there was a select committee to investigate the assassinations of President Kennedy and Dr. Martin Luther King, but through a series of unfortunate events, I lost control of this committee -- the only vehicle that the Congress has ever established for the purpose of an honest review. As you must also know, I was the prime sponsor of the legislation creating this select committee.

Since it was not possible for me to conduct the kind of investigation I had in mind, I am not in a position to pass on anything to you. The committee during its existence spent a lot of money, with little results.
