Tnx 10/21/74 and UPI wire copy same date.

Returned last night from ednently successful and utterly exhausting hearing that while it was tremendously stimulating in terms of what I was able to do was also taxing beyond ability to convey.

No reporting and less wire copy by incompetents or inexperienced can begin to describe what we did, beginning by establishing a new precedent (terms rights accused) to discovery by habeas corpus petitioners and in the record we made.

Last coup kidnapping all State's rebuttal witnesses and making them ours. Wish I could tell you how able to do this when all were surprise witnesses!

They actually peeped out and rested case because of this.

Do expectrietary this hearing (which still requires six tough weeks of work) and trial, which will require God alone can begin to guess what.

Have a new underground book everdne and have had to let is go to do this work.

Fereman and Muie dared not show up in court and be cross-examined in public, hence State trickery in using depositions which on balance help us from what the peer reporting does not include. They call each other perjurers. And neither ever intended defending Ray.

Ray stacked up so well on cross-examination the State gave up on him hours before we expected it or they had predicted.

He has been truthful, with a dry wit the State lawyers could not cope with.
