

Dear Jim, Re; FBI's files on me; HQ and FO non-compliance; Bringuier and  
Dione Turner

2/7/78

When I can I'll be giving you memos on individual records when there seems to be a point in doing so. In this I'll be addressing the FBI's techniques of defamation, non-compliances (which makes me think we should ask for affidavits of compliance) and some of the specifics of the records.

This copy of 62-108060-6593 is the file copy of the Domestic Intelligence Division. Sullivan's is the only name marked in the stamp for routing and the rubber stamp visible in reverse at the bottom is of that Division.

there is a notation only partly comprehensible at the lower left-hand corner of the first page. It appears to say Retained in 81.8, the second 8 unclear and possibly not an 8. It overlaps with a rubber stamp that in reverse reads "negative." I'm not certain this is the entire rubber stamp.

To the left of this is another stamped-on form. I believe that in the part not eliminated the initials that remain are of Raymond E. Long, if I recall that name correctly.

Above these notations is the routing of copies by the N.O. field office. With the three copies sent to the Bureau there are 9 enclosures, none of which I saw when I went over this covering Airtel and the rest of the volume. If they are mentioned in the LHM, which also has an "enclosure" stamp, I'll go into that as I read the LHM. I've skimmed only part of the first page to now.

I'd have assumed a copy to Dallas but not to Houston. This is absolute proof that a denial of any records by the Houston F.O. is knowingly false.

One enclosure to it and to Dallas. HQ stamped 9 enclosures also.

HQ also noted what appears to be "SNIP 6592. Whatever this means, there is no 6952 in this Section. At the same point there is another file designation, 44 1-A-3. With 44 indicating "Civil Rights," I wonder if this is a sub of a Kin file.

The names and initials added are Sullivans, WCS for William C. Sullivan, Branigan, what can be Raupach (there is such a name) and Goble, I take it Theodore N. Goble, who with Raupach figures in the records on me and I think other critics.

The underscorings are indicative of indexing indications. I do not recall having seen the wavy line below the names like below those of Bringuier and Turner in records I have gone over in the past. Perhaps it can be their way of noting informers to the file clerks.

Maybe the 9 enclosures are those copies of the LHM and the 3 at the bottom refers to the Airtel copies.

While it is customary to say that Bufiles contain no "derogatory information" on people, as here on Turner, they do not say no information at all. She was, if not their informant or source, without question a narcotics informant, at least for the N.O.P.D., Giarruso and Sgt. Spako. I checked this out. In fact, traced here there once to be sure. She may or may not have been a narcofink but she was well known to the two agents to whom I spoke and to whom I'd heard her speak by phone. Here I mean federal agents, federal fink.

Dione is not a common name and Bringuier fractures English badly. That he has the name right means to me that she did not lie to me about her earlier knowledge of and meetings with Bringuier, on some occasions with the Philip Geraci who is mentioned. On one of those occasions, when he had run away and had returned to N.O., she met him and drove him to Bringuier's. Here I do not depend on her word. I have the juvenile report referred to quite incompletely. Geraci understated some of it. Instead of phoning his parents or the police Bringuier arranged to put him up at the Silver Dollar, where the boy was gang-banged.

Dione may have received the letter from Geraci she has said to have said she received but it could not possibly have said what is attributed to it.

Because I intend some carbons for other uses and filings here I ask that what I say about those who then were young people be kept confidential.

Dione, Philip and one Raul Navas were what for them would pass as friends. Raul was not much of a person from my experience with him. I believe Philip was honest with me and would have been more honest if it had not been for his mother. I believe that she forced him to break off with me.

This whole business marks one of the unethical practises of the Garrison office, I'm sure at Jim's direction. They broke their word to stay out of this when I told them about it. As usual they were utterly incompetent when they tried to steal what I was doing and would have given to them. I became quite angry on a couple of occasions and then addressed Jim and Moo Sciambra as I'm certain they had not been addressed.

One aspect was calling Raul in for an interview. He used it for a credited character assassination of Dione, whose character made that easy. But the stupidities of the Garrison office were not aware that she was also an excellent source, in some areas far and away my best, even though she is the most natural and persuasive and accomplished liar I ever knew well. Fantastic liar! I was lucky in deciding what to check out. All paid off.

So I got Ivon to call Raul in for an interview by me. Raul agreed. Ivon left us alone and I broke Raul down. It was easy with the guidance I obtained from Dione, who was, naturally enough, put out over what he had done to her. I don't recall if Ivon kept the tape to which Raul agreed. If I have it I don't recall where it is.

She knew and had gone out with Layton Hartens and Perry Russo. They both confirmed her stories to me. By the most remarkable of coincidences the night I persuaded her to trust me, at Barbara Reid's apartment, who turns up in the wee hours by Hartens, wanting to know what is going on.

However, none of this part of the LHM is true. As of that time I'd never spoken or written to Philip. About April of that year I did interview Philip's father and mother, on tape, played back to them. I obtained proof of Bringuier's false swearing to the Warren Commission - about Oswald and about when he met Oswald. I interviewed Philip in the home of his lawyer, by pre-arrangement, and that it be in the lawyer's presence being my idea, that December.

In between the father, an electrician, died as the result of an electric shock.

Dione had told me that Philip and Raul were homosexual. Garrison had a hangup on homosexuals over Shaw. She also told me that Shaw's pal Mario Bermudez had seduced Philip using a fancy car as bait and even telling me where the first encounter took place. I received partial confirmation from the parents, to whom I did not identify Philip with the use of that particular place popular among high school kids by wealthy New Orleans homosexuals. They are among those who made representations to the Metairie school authorities.

One of my purposes was to protect Philip. Another was to learn what I could from him. With the first, which is entirely opposite what this LHM says, I was completely successful. With the second very successful. Had I been able to spend more time in N.O. or to look him up later it could have led to much more good information.

If you want I'll tell you about the Philip-Ferrie connection. It is not relevant here. And of what happened to Philip within 24 hours of Ferrie's death, confirmed by the mother. I have these tapes.

Philip was in Viet Nam. Garrison had no plans for subpoenaing him from there. It is when Philip was returned after his father's death that Garrison wanted to talk to him. The kid was so scared he ran the risk of ignoring three subpoenas. I found out not from Garrison but from Dione.

With this record Garrison was quite willing to make a deal with me. I made it through Alcock and arranged for the lawyer's husband, a judge, to confirm the deal so she'd know that on my own I'd arranged to shelter her client. They both, as a matter of fact, told me how unusual they found this and how much they appreciated it.

Lillian Cohen practise law under her maiden name. She was married to Judge Louis Trent. I helped her when the cop turned hippie was framed with a phoney plot to kill Nixon when Nixon needed a sympathetic press. This was when he addressed the VFW in N.O. The story then out out was so direct a steal from a N.O. Oswald story that appears never to have reached the Commission I was able to tell John South of the Enquirer what drug store it was supposed to have been overheard in - and I was right. Poor Hippie Gaudet might have been killed for no reason except Nixon's need for sympathy. Lillian Cohen was his lawyer.

This bears all the earmarks of one of Dione's games because of the relationship each of these falsehood bears to what I can trace to her. Not that Bringuiet had hired Geraci. He talked the kid into selling phoney Cuban bonds, without being hired. Not that Bringuiet and others had gone to a Cuban camp near New Orleans but that she and the two boys had and had seen Oswald there. These are her stories to me. I don't know if they are true or not. I'm inclined to doubt it save for two reasons: she knew the location of the camps and gave me an accurate description of one of which I was able to obtain pictures during 7/68.

So all of this as it relates to me is false. Note here that the LHM does not include such qualifiers as Bringueir said or it is alleged. They present it all as established fact. I presume this is because the NO FO knew enough about me.

The first sentence of the third graf is another typical lie. The mother had not been approached by Garrison. It is I to whom she and the father spoke, feely and openly at their home, with the taping in the open and as the tapes show, played back so they could be certain than in anxiety that had not misspoken themselves. (Now how many are this concerned when delicate family questions are involved and with Garrison's by then well-known proclivities? But I also had not made a deal for the mother. Later I did.)

The next sentence is also presented as unquestioned truth. In fact it is fabrication. Attention is drawn to it by the note on the first page "See end p. 177 The words are: \*Turner commented that an agency which she did not identify was building a case against Weisberg because he was spreading KGB propoganda in the United States.\* Fabrication unless she knew what she did not tell me.

The sentence at the top of the ~~next~~ <sup>next</sup> page is based on something real but is false. Philip was being returned over his father's death, if by October his father had died.

The story of the Bringuiet-Geraci relationship is at best incomplete. It is in this ~~xxx~~ area that Bringuiet swore falsely to establish an alibi for himself.

The parents made Philip stop selling th bonds. I have the receipts he got from Bringuiet. It is almost certain that Oswald filed the complaint against Bringuiet's unlicensed sale of bonds. And that he told Bringuiet about it at the court hearing after the 8/63 fracas.

The date 8/5/63 is one of the two different false dates Bringuiet gave for the Oswald meeting.

Notice, however, that the N.O.F.O. did have a file on Geraci. Why? I can think only of his connection with the case, with me or both. It was not long after my joint interview with both the mother and Philip that I got reports of FBI agents going around behind me and defaming me to those I'd spoken to. Notice the date, 5/5/68 for a minor juvenile offense of more than three years earlier.

Bourne's long report says more than this and says what this does not say. It includes Turner at several points and in some detail. (I have it.)

This tailored version seems designed to make it easy to destroy Philip's credibility. And to support Bringuiet's false testimony. Actually Philip hated his parents, and not without cause. He was institutionalized over his campaign to get even with them, especially the father.

If I were to guess at a Houston connection I could not overlook that Ricardo Davis was then there.

ASSASSINATION OF PRESIDENT  
JOHN FITZGERALD KENNEDY  
NOVEMBER 22, 1963  
DALLAS, TEXAS

Carlos Bringuier, New Orleans delegate to the Cuban Student Directorate (CSD), appeared in the New Orleans Office of the FBI on October 10, 1968, and furnished the following information:

He advised that he was visited by Dione Turner on the afternoon of October 9, 1968. She furnished her address as Post Office Box 1282, Louisiana State University in New Orleans, Louisiana, 70122. Turner advised Bringuier that she had received a letter from Philip Geraci, III, approximately two weeks ago. Geraci is presently in the United States military stationed in Vietnam. Geraci advised Turner in his letter to transmit a message for him to Carlos Bringuier. Geraci advised that he had been contacted by Harold Weisberg, author of the book, "WHITENASH," who has been assisting New Orleans District Attorney James Garrison in his investigation of the assassination of President John Fitzgerald Kennedy. Geraci did not advise Turner as to what method Weisberg had used in contacting him. Geraci claimed that Weisberg indicated that he, Geraci, would be subpoenaed by the New Orleans Grand Jury through the efforts of District Attorney Garrison if he did not state that he had previously been hired by Carlos Bringuier and that he, Bringuier, and some other Cubans had gone to a training camp for Cubans in the New Orleans area. Weisberg added that if Geraci did not comply with this request he would be indicted by the Orleans Parish Grand Jury for perjury.

Turner further advised Bringuier that Geraci's mother had been cooperating with Garrison and had made some type of deal with him. She did not indicate what kind of deal had been made. Turner commented that an agency which she did not identify, was building a case against Weisberg because he was spreading KGB propaganda in the United States. Turner did not identify this agency to Bringuier.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

Turner stated that Geraci is due to arrive in New Orleans shortly as one of the members of his immediate family is very ill. She added that she does not know what Geraci plans to do regarding this situation.

Bringuer advised that he told Turner to write Geraci and tell him to go ahead and testify before the Orleans Parish Grand Jury and tell the truth. Bringuer stated that he first met Geraci in 1963 when Geraci, who was of high school age, came into his store, the Casa Roca, 107 Decatur Street, New Orleans, to inquire about what he might do to assist in any anti-Castro activity. Bringuer stated that he gave Geraci some material to read and at one time gave him some bonds to sell from which the revenue would be used to support anti-Fidel Castro activities. Bringuer stated Geraci did not receive a commission for selling these bonds and was not employed by him. Geraci discontinued the sale of bonds as he claimed he was stopped by an officer, not identified, who stated he could not sell these bonds without a permit. Bringuer related that he again saw Geraci on August 5, 1963, at the Casa Roca. Geraci was again interested in discussing anti-Castro activity and was accompanied by a companion. While Bringuer, Geraci and his companion were talking, Lee Harvey Oswald entered the Casa Roca and showed interest in joining the CSD and in obtaining as much information as possible concerning this organization's activities. Bringuer advised that he excused himself at this time to make a deposit in the bank and left Geraci, his companion and Oswald talking. Bringuer added that he has only seen Geraci once since August 5, 1963, and this was at a showing of Vietnam films in the New World Theater at 1117 Decatur Street in New Orleans in 1966 or 1967.

The following concerning Philip Geraci, YKA, is contained in the files of the New Orleans Office of the FBI:

Deputy Sheriff Don Borne, Juvenile Division, Jefferson Parish Sheriff's Office, Gretna, Louisiana, advised on May 5, 1968, that Geraci, whose home address was 2201 Green Acres Road, Metairie, Louisiana, in 1965, ran away from his residence on April 20, 1965. Geraci, in fact, was under psychiatric treatment. He affiliated with Cubans who were anti-Fidel Castro in their political outlook.

Philip Geraci, Jr., of the above address and the father of Geraci, III, advised on May 5, 1965, that the family physician had placed his son on tranquilizers and ordered him to receive psychiatric treatment. He received this treatment at the Tulane University Medical School in New Orleans. Geraci, III, was to have had an appointment with his psychiatrist on April 20, 1965, the day he ran away from home, and may have run away because he thought he might be committed for psychiatric treatment.

On May 29, 1965, Deputy Sheriff Borne advised that Geraci, III, had been arrested at Jackson, Mississippi, and released to his parents in Metairie, Louisiana, in order that he be committed privately to an insane asylum.

On July 30, 1965, Geraci, III's, parents had him privately committed to the State Hospital at Mandeville, Louisiana, for treatment. He had been diagnosed with schizophrenia reaction with obsessive compulsive features and with the recommendation for further evaluation and treatment.

Geraci, III was interviewed by Bureau Agents on November 29, 1963, concerning his meeting Lee Harvey Oswald at the Casa Roca on August 5, 1963. Information furnished by Geraci paralleled information regarding this incident as furnished by Carlos Bringuier, above. Geraci stated that he and his companion talked to Oswald for approximately ten to fifteen minutes concerning various guerilla tactics, firearms and other subjects. Geraci stated, during this interview, that he could not recall Oswald discussing Marxism, Communism or any other political philosophy at this time. Geraci added that he had no further contact with Oswald other than that one incident.
