Dear Henry,

I've not been in touch with you because I am embarrassed that the Times-Herald reporter embarrassed you. It was not my intention. As you know, I've never mentioned anything about you and didn't even use what you wrote and told me I could use.

I write you now because there is much craziness afoot down there now and it may involve people you know. Whether or not it does, they ought not be associated with a complete and total fabrication that has gotten much attention. I've just heard that a man who says he is a licensed legal investigator, Joe West, has an appointment with your successor. I've been sent copies of newspaper stories saying that the State Attorney General has expressed an interest and would look into it.

This is the business of a former Dallas policeman, Roscoe Anthony White, being said by his son to have been one of three JFK assassins and the one who killed Officer Tippit. No part of the commercialization Ricky White, the son, is putting out, is true, except that his father was a Marine and was a policeman and before that an employee of the police department. Some of it is stolen from two books and what is stolen from them is from them only, having no other source, and also is fabricated. (I worked on the proposal for one of the books for a publisher and assure you it was all made up.)
